EX-SERVICEMEN CONTRIBUTORY HEALTH SCHEME

Will the Minister of DEFENCE be pleased to state:

(a) the salient features of the Ex-Servicemen Contributory Health Scheme (ECHS);

(b) the number of beneficiaries who have availed services through ECHS during the last three years;

(c) the amount incurred by the Government under the Scheme; and

(d) the details of the hospitals empanelled under ECHS across the country, State/UT-wise including Bihar, district-wise?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF DEFENCE

(SHRI SANJAY SETH)

- (a): (i) The Ex-Servicemen Contributory Health Scheme (ECHS) became operational on 01st April, 2003 for Ex-Servicemen drawing defence pension alongwith their eligible dependents. The scheme provides cashless and capless medical benefits to approximately 60 lakh beneficiaries. Special sanction of the Government of India has been granted on 07th March, 2019 to World War-II Veterans, emergency Commissioned Officers, short service commissioned Officers and Pre-Mature Retirees by waiving off the mandatory conditions of being Ex-Servicemen and drawing pension from Controller of Defence Accounts.
 - (ii) ECHS provides medical services through a vast network of 427 ECHS Polyclinics in India, 06 in Nepal, 30 ECHS Regional Centers and Empanelled Health Care Organizations.
 - (iii) Personnel from the following organizations/categories, apart from the Tri-services, are entitled for ECHS membership: -
 - (1) Territorial Army
 - (2) Defence Security Corps
 - (3) Uniformed Indian Coast Guard

- (4) Military Nursing Service
- (5) Special Frontier Force
- (6) Nepal Domiciled Gorkha
- (7) Whole time NCC officers
- (8) Army Postal Service
- (9) Army Rifles
- (10) World War-II Veterans, Short Service Commissioned Officers (SSCOs), Emergency Commissioned Officers (ECOs) & Pre Mature Retirees.

(b): Around 3.55 Crore number of visits have been reported in ECHS Polyclinics by ECHS beneficiaries for treatment/referral through ECHS in the last three years.

(c): The amount spent by the Department of Ex-servicemen under the scheme during the last three years is Rs. 21,589.31 Crores and for the current year is Rs. 2,688.86 Crores (as on 22nd July, 2024).

(d): Details of the empaneled Health Care Organisations under ECHS across the country, State/UT-wise including Bihar district-wise is placed at Annexure.
