Capacity Building under Ayurgyan Scheme

*263. Shri Bastipati Nagaraju:

Will the Minister of Ayush be pleased to state:

- (a) the details regarding the total number of institutes/organizations including Government and Private which have applied under the Capacity Building and Continuing Medical Education component of AYURGYAN Scheme in the country, State/UT-wise, especially in Andhra Pradesh;
- (b) the total number of proposals received both proactive approach and reactive approach from the State of Andhra Pradesh and sanctioned for the last three years;
- (c) the details of total amount of funds allocated to the components such as Capacity Building & Continuing Medical Education (CME) and Research & Innovation in AYUSH, State/UT-wise;
- (d) whether the Government has any data regarding the total number of trainees trained under the Capacity Building & Continuing Medical Education component and if so, the details thereof; and
- (e) whether the Government has conducted or plans to conduct any impact study/assessment to review the effectiveness and outcome of the scheme and if so, the details thereof?

STATEMENT REFERRED TO IN REPLY TO LOK SABHA STARRED QUESTION NO. 263 FOR 13th DECEMBER, 2024

(a) 'Capacity Building & Continuing Medical Education (CME) in Ayush' is one of the component of Central Sector Scheme namely Ayurgyan which is implemented since 2021-22. The overall structure of CME is aimed to encourage Ayush personnel to undergo need-based professional training and bridge the knowledge gaps.

Under 'Capacity Building and CME' component, total 147 institutions/organizations from 20 States/UTs have applied viz. 22 in Maharashtra, 16 in Tamil Nadu, 15 in Karnataka, 13 in Uttar Pradesh, 12 in Madhya Pradesh, 11- Gujarat, 08 in Delhi, 7 in Rajasthan, 7 in Telangana, 6 in Kerala, 5 in Odisha, 5 in West Bengal, 4 in Haryana, 4 in Uttarakhand, 3 in Assam, 3 in Himachal Pradesh, 3 in Jammu & Kashmir and 01 each in Andhra Pradesh, Meghalaya and Punjab.

- (b) Being the Central Sector Scheme, the organizations can send proposals directly to the Ministry of Ayush in the reactive approach for seeking financial assistance for conduction of training program under CME component. 02 proposals viz. 01 (6-days) CME program for teachers on Panchakarma and 01 (6-days) CME program for Ayurveda Medical Officer were received on reactive approach and sanctioned to the organization situated in the State of Andhra Pradesh during the last 03 years.
- (c) Under the Ayurgyan scheme, an amount of Rs.35.92 Crore (viz. Rs.17.95 Crore for Capacity Building & CME component and Rs.17.97 Crore for Research & Innovation in Ayush component) has been allocated for the FY 2021-22 to 2024-25. A third (new) component namely Ayurveda Biology Integrated Health Research was added during the FY 2023-24 under the scheme with a financial allocation of Rs.46.16 Crore and thereafter, the total allocation of Ayurgyan scheme increased to **Rs.82.08 Crore** till the FY 2024-25. Being the Central Sector Scheme, the funds are released directly to the eligible institutions situated in various States/UTs. Details of funds released, to the eligible institutions, in various States/UTs is at Annexure.
- (d) Yes, under Capacity Building & CME in Ayush component, total 4862 trainees viz. 761 trainees in FY 2021-22, 2299 trainees in FY 2022-23, 1350 trainees in FY 2023-24 and 452 trainees in FY 2024-25 (as on 10.12.2024) were trained.
- (e) This Ministry has not conducted any impact study/assessment till date to review the effectiveness and outcome of the scheme.
