(a) the number of beneficiaries assisted under various schemes in Odisha, particularly in Jharsuguda and Bargarh districts during the last five years;

(b) the details of the funds allocated and utilised under the said schemes in Odisha, particularly in the said districts during the said period, scheme-wise;

(c) the number of Micro, Small and Medium Enterprises (MSMEs) and start-ups established in Odisha, particularly in the said districts during the said period;

(d) the details of funds allocated and utilized for MSMEs and start-ups in Odisha, particularly in the said districts during the said period;

(e) the details of loans sanctioned under the schemes like Mudra Yojana, PMEGP and Stand-Up India in the said districts of Odisha; and

(f) the total funds disbursed and repaid under these loan schemes?

# STATEMENT REFERRED TO IN REPLY TO PARTS (a) to (f) OF THE LOK SABHA STARRED QUESTION NO. \*353 FOR ANSWER ON 19.12.2024.

(a) to (f): Government implements various Central Sector schemes and programmes aimed at promotion and development of MSME Sector and thereby create employment including in the State of Odisha. These schemes/ programmes include Prime Minister's Employment Generation Programme (PMEGP), Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE), PM Vishwakarma (PMV), Micro and Small Enterprises - Cluster Development Programme (MSE-CDP) and Raising and Accelerating MSME Performance (RAMP), MSME Champions Scheme, Entrepreneurship and Skill Development Programme (ESDP), Procurement and Marketing Scheme(PMS)etc.

Since inception of the Udyam Registration portal on 01.07.2020, as many as 17,88,688 MSMEs have registered in Odisha which includes Informal Micro Enterprises, providing employment to 82,72,656 persons. The details are at Table below:

vi: Startup India:

The Government, with an intent to build a strong ecosystem for nurturing innovation, Startups and encouraging private investments in Startup ecosystem of the country launched Startup India initiative on  $16^{\text{th}}$  January 2016.

Under the Startup India initiative, the Government is implementing flagship Schemes such as the Fund of Funds for Startups (FFS) and Startup India Seed Fund Scheme (SISFS) to support Startups at various stages of their business cycle. FFS has been established to catalyze venture capital investments and is operationalized by Small Industries Development Bank of India (SIDBI), which provides capital to Securities and Exchange Board of India (SEBI)-registered Alternative Investment Funds (AIFs) which in turn invest in Startups. AIFs supported under FFS are required to invest at least two times of the amount committed under FFS in Startups. SISFS provides financial assistance to seed stage Startups through incubators. SISFS is implemented from 1<sup>st</sup> April 2021.

Under FFS Alternative Investment Funds (AIFs) have invested Rs. 20,572.14 Crores in Startups. Under SISFS, Rs. 902.74 Crore have been approved to the Incubators.

As on 31<sup>st</sup> October 2024, 1,52,139 entities have been recognised as Startups by Department for Promotion of Industry and Internal Trade (DPIIT). As many as 1,08,457 entities have been recognised as Startups in the last five years viz. 2019, 2020, 2021, 2022, and 2023.

For the State of Odisha, 2,670 entities have been recognized as Startups as on 31<sup>st</sup> October, 2024 of which, 1,935 entities have been recognized as Startups in the last five years viz. 2019, 2020, 2021, 2022, and 2023.

In the district of Jharsuguda, 21 entities have been recognized as Startups as on 31<sup>st</sup> October 2024, of which 16 entities have been recognized as Startups in the last five years viz. 2019, 2020, 2021, 2022, and 2023.

In the district of Bargarh, 19 entities have been recognized as Startups as on 31<sup>st</sup> October 2024, of which 15 entities have been recognized as Startups in the last five years viz. 2019, 2020, 2021, 2022, and 2023.

For the State of Odisha, approved AIFs have invested Rs. 6.31 crore in 3 Startups as on 31<sup>st</sup> October 2024 under FFS.

For the State of Odisha, approved incubators have selected 74 Startups for a total approved funding of Rs. 9.94 crore as on 31<sup>st</sup> October 2024 under SISF.
