### TRAINING COURSES FOR YOUTH

†1108. SMT. SANJNA JATAV:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state: -

- (a) whether the Government has got any research study survey done for providing provision of training courses for youth across the country with an objective of skill development or skill upgradation under the Pradhan Mantri Kaushal Vikas Yojana (PMKVY), if so, the details thereof;
- (b) the total number of people who participated in such courses, State-wise particularly in the State of Rajasthan during the last five years;
- (c) the details of funds solicited and utilised by such training centres in Rajasthan during the last five years, district-wise particularly in regard to Bharatpur District; and
- (d) whether the Government has conducted any awareness programme with the objective of providing knowledge to the citizens regarding skill development/skill upgradation courses available under the PMKV Yojana and carried out any promotional activities, and if so, the details thereof?

### **ANSWER**

THE MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(SHRI JAYANT CHAUDHARY)

A robust stakeholder consultation and regulatory framework has been established for conducting necessary research/study/survey to provide training courses under Pradhan Mantri Kaushal Vikas Yojna (PMKVY) to youth for purposes of skilling, upskilling and/or reskilling. Sector Skill Councils (SSCs), mandated under the National Policy on Skill Development and Entrepreneurship (2015), actively engage with industries to identify skill gaps through regular consultations and studies. The National Skill Development Corporation (NSDC) commissions studies focusing on both Indian and global labour markets to ensure comprehensive skill assessments. Based on these consultations and studies, competency standards and qualifications are developed for high-demand job roles. These qualifications undergo validation through consultations with industries accredited by the National Council for Vocational Education and Training (NCVET). Validated qualifications are then added to the National Qualification Register (NQR) and aligned to the National Skills Qualification Framework (NSQF). All training courses offered under PMKVY are drawn from this National Qualification Register (NQR) and are developed based on industry consultation and skill gap surveys as detailed above. In addition to the above, District Skill Development Plans (DSDPs) have

been developed by District Skill Committees (DSCs) to assess skill gaps, mapping of industry demand, etc. at district level to ensure alignment of PMKVY courses with local needs. Further, an Impact Evaluation of the Pradhan Mantri Kaushal Vikas Yojana was also conducted in the year 2019 to evaluate the impact of the scheme.

- (b) Under PMKVY, 95.61 lakh candidates have been enrolled in the last five years across the country. State-wise numbers of candidates who have been enrolled during the last five years under PMKVY are given at *Annexure I*.
- (c) Under PMKVY 2.0 and 3.0, there were two components: Centrally Sponsored Centrally Managed (CSCM) component, implemented through the National Skill Development Corporation (NSDC), and Centrally Sponsored State Managed (CSSM) component, implemented through the States Skill Development Missions (SSDM) of various states. PMKVY 4.0 is a Central Sector Scheme. There is no provision of Statewise funds allocation.

During PMKVY 2.0 and 3.0, ₹26.19 Crores were released under CSSM component to Rajasthan. All the funds have been utilized by the State. District wise details of funds disbursed by NSDC under PMKVY in Rajasthan, including Bharatpur district during the last five years (2019-20 to 2023-24) are at *Annexure-II*.

(d) Yes, the MSDE has undertaken various awareness campaigns and promotional activities to inform citizens about the skilling, upskilling and reskilling courses available under the PMKVY through comprehensive multimedia campaigns across television, radio, print, and digital platforms; periodic media briefings with vernacular, regional and national media; active engagement on social media platforms; and community engagement initiative. Regular Press releases have also been issued through Press Information Bureau (PIB), Doordarshan, MyGov and other government and private news agencies. Awareness has also been created through our wide network of training institutes to disseminate information and encourage participation in the scheme. Utilizing the MSDE's digital initiative – 'Skill India Digital Hub' (SIDH), citizens can access detailed information about PMKVY courses, enroll in training programs, and locate the nearest centers where the scheme is running.
