- (a) the details of the Geographical Indication (G.I.) Tagged products in the country, State/UTwise;
- (b) the details of budget sanctioned for protection of these G.I.Tagged products, product-wise; and
- (c) whether the Government proposes to provide G.I.Tag to the famous Mahua and Anura (Sitafal) of tribal areas in the southern Rajasthan and if so, the details thereof and if not, the reasons therefor?

- (a): The details of Geographical Indications (GI) tagged products in the country, State/UT wise is available on DPIIT's website under the links

- (b): There is no specific product wise amount sanctioned for protection of GI tagged products. However, the details of budget sanctioned for office of CGPDTM and GI Registry, which inter-alia, grants registration and protection of GI products under GI Act and Rules is attached as Annexure I. Additionally, an amount of 75 Crores Rupees was sanctioned for Financial Year 2022-23 to 2024-2025 for the purpose of promotion, awareness and to enhance the registration of Geographical Indication products.
- (c): The Office of Geographical Indications Registry has not received application for registration for Mahua and Anura (Sitafal) of tribal areas in the Southern Rajasthan as Geographical Indication. Application needs to be submitted by a producers' association or an authorised body representing the interests of the producers, in accordance with the GI Act and Rules, for registration of a product as GI.
