(a) whether the Government is distributing artificial limbs and supportive devices to the Specially abled persons;

(b) if so, the details thereof during the last three years, State-wise including Delhi; and

(c) if not, the reasons therefor?

#### ANSWER

# MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SHRI B. L. VERMA)

(a) to (c) The Department is implementing the Scheme of Assistance to Persons with Disabilities for Purchase/Fitting of Aids/Appliances (ADIP Scheme) throughout the country through various Implementing Agencies viz., National Institutes/Composite Regional Centres/Artificial Limbs Manufacturing Corporation of India (ALIMCO)/District Disability Rehabilitation Centres/State Development Corporations working in field of Disabilities/other Local Bodies/ Non-Governmental Organizations (NGOs). Under the scheme, Durable, modern and scientifically manufactured aids and assistive devices including Artificial Limbs are provided to Persons with Disabilities (PwDs) for promoting their physical, social and psychological rehabilitation, thereby reducing the effects of disabilities and enhancing their educational and economic potential. The funds are released to various Implementing Agencies for the purchase, fabrication, and distribution of such standard aids and appliances including Artificial Limbs that are in conformity with the objectives of the Scheme. Implementing Agencies take care of/ make suitable arrangements for fitting and post-fitting care of aids and assistive devices including Artificial Limbs distributed under the Scheme. The details of number of beneficiaries distributed with aids and appliances state-wise including Delhi during last 03 years is at Annexure.
