- (a) the quota of ration allocated to each State of the country under the 'One Nation One Ration card' scheme;
- (b) whether the Government of Delhi regularly draws its designated quota of ration under the said scheme; and
- (c) if so, the details thereof?

ANSWER

MINISTER OF STATE FOR MINISTRY OF CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SHRIMATI NIMUBEN JAYANTIBHAI BAMBHANIYA)

(a): The Department of Food & Public Distribution (DFPD) has implemented portability of ration cards under One Nation One Ration Card (ONORC) across the country. Since the inception of ONORC, more than 156 Crore portability transactions have been recorded. DFPD allocates additional food grains, every quarter, to States/UTs under ONORC, for the distribution of food grains to beneficiaries from other States/UTs. The information on additional allocation of food grains under ONORC during the years 2023-2024 and 2024-2025, State/UT wise, is attached as Annexure-I.

(b) & (c): The Government of Delhi regularly draws its designated quota, as allocated under ONORC. The allocation and lifting of food grains in respect of Delhi, for FY 2023-24 and FY 2024-25 (up to 25.11.2024) is below:
