1855. SHRI IMRAN MASOOD:

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) the total number of hospitals empanelled and functioning since 2023, month and year-wise; and
- (b) the steps taken by the Government to increase the number of Enlisted Health Care Providers (EHCPs) per beneficiary?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI PRATAPRAO JADHAV)

(a) & (b) As on date, the information regarding Hospitals empanelled under CGHS, CS(MA) Rules, 1944 and Ayushman Bharat PMJAY is attached at Annexure-I, Annexure-II and Annexure-III respectively.

Empanelment of Private Hospitals under the above schemes is a continuous and voluntary process, in which the intending Private Hospital may apply for empanelment. Private Hospitals fulfilling the laid down criteria are empanelled under the scheme.

Although Hospital empanelment is a voluntary process, the steps taken under PMJAY to improve the participation of hospitals, are as follows:

- (i) NHA has released a revised health benefit package, under which rates are increased for 350 packages and new packages are added.
- (ii) Claim settlement are regularly monitored to ensure settlement within defined turnaround time.
- (iii) Virtual and physical capacity building of hospitals are being undertaken.
- (iv) A hospital-specific call center (14413) has been set-up to address the concerns of hospitals on a real-time basis.
