OPERATIONAL EMPLOYMENT EXCHANGES

199. SHRI VISHNU DAYAL RAM:

Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a) the number of operational employment exchanges in the country, State-wise including Jharkhand;
- (b) the details of the present status of upgradation and modernization of employment exchanges in the country, State/UT-wise;
- (c) the details of funds allocated, released and utilized respectively during each of the last three years and the current year, State/UTwise;
- (d) whether the progress of modernization is being carried out as per target in this regard in all the States including Jharkhand and if so, the details thereof and if not, the reasons therefor; and
- (e) the other steps taken by the Government in this regard?

ANSWER

MINISTER OF STATE FOR LABOUR AND EMPLOYMENT (SUSHRI SHOBHA KARANDLAJE)

(a) to (e): As per the extent of information received from States/UTs there are about 1008 employment exchanges in the country, out of which 43 are in Jharkhand. The number of employment exchanges in the country, State-wise is at Annexure I.

Government is implementing the National Career Service (NCS) Project to provide a variety of employment related services like job matching, career counselling, vocational guidance, information on skill development courses, etc. Under the project NCS, the Government is providing financial assistance for upgradation of Employment Exchanges to Model Career Centres (MCCs). As on 22.11.24, proposal for up-gradation of 370 Employment Exchanges to MCCs in the country has been approved. The state-wise list of approved MCCs, details of funds allocated, released and utilized during the last three years and the current year is at Annexure II.
