## GOVERNMENT OF INDIA MINISTRY OF HOUSING AND URBAN AFFAIRS LOK SABHA UNSTARRED QUESTION NO. 2799 TO BE ANSWERED ON DECEMBER 12, 2024

#### **EFFECTIVE IMPLEMENTATION OF NULM**

NO. 2799. SMT. DELKAR KALABEN MOHANBHAI: SHRI RAVINDRA DATTARAM WAIKAR: SHRI GYANESHWAR PATIL:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the manner in which the Government proposes to address funding constraints to effectively implement the National Urban Livelihoods Mission (NULM) programmes across the country including Mumbai, Maharashtra and Dadra and Nagar Haveli and to reach out to the large population of urban poor;
- (b) whether the NULM has addressed the skill mismatch between the requirements of urban poor and industry by ensuring employability and sustainable livelihoods;
- (c) if so, the details thereof, State/UT-wise including Dadra and Nagar Haveli and Madhya Pradesh; and
- (d) the manner in which the technology is likely to be used more effectively to improve the monitoring and evaluation of programmes running under the said mission in the country and to improve the overall impact of its initiatives?

#### ANSWER

# THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI TOKHAN SAHU)

(a): 'Land' and 'Colonization' are State subjects and the implementation of schemes/programmes under this is the responsibility of State/UT Governments. Ministry of Housing & Urban Affairs (MoHUA) supplements the effort of States/UTs by providing Central Assistance under "Deendayal Antyodaya Yojana - National Urban Livelihoods Mission (DAY-NULM)". Based on requirements received from States/UTs and the utilization of funds available with them, including State of Maharashtra and UT of Dadra and Nagar Haveli, funds have been released to them for effective implementation of the scheme.

- (b) & (c): The Employment through Skill Training & Placement (EST&P) component under the Mission aimed to provide skill training to urban poor in market-oriented courses, enabling them to set up self-employment ventures or secure salaried employment. Further, Self-Employment Programmes (SEP) component provides for financial assistance to individuals/ groups/ SHGs of urban poor for setting up gainful self-employment ventures or micro enterprises. Under the mission, as on 20.11.2024, a total number of 8,73,701 skilled candidates have been placed. State/UT-wise details of skilled randidates who have been placed including UT of Dadra and Nagar Haveli and State of Madhya Pradesh is attached at Annexure I.
  - (d): The Progress under the scheme is monitored through NULM-MIS web portal. Further, Urban Livelihood e-Learning and Resource Network (U-LEARN), an e-Learning tool has been developed to enhance the skills and knowledge of DAY-NULM functionaries. It is accessible through mobile based application as well as web-based platform. Moreover, a centralized online platform viz. Portal for Affordable Credit and Interest Subvention Access (PAiSA) portal has been developed for processing of interest subvention on bank loans to beneficiaries under the Mission.

To enhance program delivery, monitoring and evaluation of the Mission, and for improving the overall impact, a Governing Council chaired by the Hon'ble Minister for Housing and Urban Affairs (MoHUA) and an Executive Committee chaired by the Secretary of MoHUA was formed at Central level. At the state level, the Mission is monitored by a Governing Council (GC) and Executive Committee (EC). At the City/ULB level, the Mission was monitored by an Executive Committee chaired by Municipal Commissioner. In addition, the Ministry conducted regular seminars, conferences, workshops with the States/ULBs for effective monitoring and evaluation of the scheme.
