(c) the funds sanctioned and disbursed by the Government for the said project during the last five years and the current year;

(d) the targeted date by which the said project is likely to be completed along with the fundssanctioned for the said project, city-wise; and

MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SURESH GOPI)

(a)to (e)Providing Piped Natural Gas (PNG) connections is part of the development of City Gas Distribution (CGD) network and the same is carried out by the entities authorised by Petroleum and Natural Gas Regulatory Board (PNGRB). PNGRB has authorised 11 Geographical Areas (GAs) (including 3 GAs spread over Bihar and Jharkhand) covering entire state of Jharkhand for development of CGD network. As per Minimum Work Programme (MWP) target, authorised entities have committed to provide 21,09,382 PNG connections in the authorised GAs by 2031. GA-wise details of PNG connections and MWP target in the state of Jharkhand is at Annexure-I.

No fund is released by the Government for CGD projects. The project cost for CGD projects are borne by the concerned CGD entities as per their Minimum Work Plan and technocommercial feasibility
