WOMEN OWNED MSMEs

2990. SHRI HARISH CHANDRA MEENA:
SHRI DHAVAL LAXMANBHAI PATEL:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the percentage of women owners of registered Micro, Small and Medium Enterprises (MSMEs) in the country State-wise, particularly in Gujarat and Rajasthan including Tonk-Sawai Madhopur district and Valsad (ST) Parliamentary Constituency during the last five years;
- (b) the current number of women owners of registered MSMEs in the country, particularly in the said States and said district and constituency;
- (c) the number of women-owned MSMEs in the country, particularly in the said states in the year 2024 as compared to the year 2019 and 2013 respectively; and
- (d) the steps taken by the Government to increase the participation of women in MSMEs in the country particularly in the National Capital Territory of Delhi, Gujarat and Rajasthan?

ANSWER

(a) & (b): The revised definition of Micro, Small and Medium Enterprises (MSMEs) was adopted on 01.07.2020. Since then, a total of 2,20,73,675 women-owned MSMEs have registered on Udyam Registration Portal (URP) and Udyam Assist Platform (UAP), upto 30.11.2024 in the country. State/UT-wise percentage of women-owned MSMEs registered and their numbers, particularly in the State of Gujarat and Rajasthan, are given at Annexure.

A total number of 7,803 women-owned MSMEs have registered on URP and UAP, till 30.11.2024 in Tonk and Sawai Madhopur Districts, which is 13% of the total MSMEs registered in these districts of Rajasthan.

A total number of 11,942 women-owned MSMEs have registered on URP and UAP, till 30.11.2024 in Valsad District, which is 18.24% of total MSMEs registered in Valsad district of Gujarat.

(c): The details of women owned MSMEs registered on URP, including UAP, till 30.11.2024 for the country and the States of Gujarat and Rajasthan, are as follows:

(d): The Government has taken a number of initiatives to increase the participation of women in MSMEs in the country, including in National Capital Territory of Delhi, States of Gujarat and Rajasthan. They are as given below:

- (i) Special drives for registration of women-owned MSMEs.
- (ii) To benefit women entrepreneurs, the Public Procurement Policy was amended in 2018 mandating Central Ministries/Departments/Undertaking to procure at least 3% of their annual procurement from women entrepreneurs.
- (iii) To support Women Entrepreneurs under Credit Guarantee Scheme for Micro and Small Enterprises (MSEs), 10% concession is given in annual Guarantee fees; 90% Guarantee coverage is given to women-owned MSEs, as against the 75% for other entrepreneurs.
- (iv) The Ministry of MSME implements Prime Minister Employment Generation Programme, which is a major credit-linked subsidy programme aimed at generating self-employment opportunities through establishment of micro-enterprises in the non-farm sector by helping traditional artisans and rural/urban unemployed youth. Under the Scheme, the subsidy rate for general category beneficiaries is 15% in urban areas and 25% in rural areas. For special category beneficiaries, including SC/ST/OBC/Minorities, Women, Ex-servicemen, Physically Handicapped, and those in NER, Hill, and Border areas, the subsidy is 25% in urban areas and 35% in rural areas.
- (v) Participation of women entrepreneurs in trade fairs under Procurement and Marketing Support Scheme is subsidized 100% vis-a-vis 80% for other entrepreneurs.
- (vi) To encourage entrepreneurship among women, Ministry of MSME implements 'Skill Upgradation and Mahila Coir Yojana' under Coir Vikas Yojana, which is an exclusive training programme aimed at skill development of women artisans engaged in the Coir sector.
- (vii) The Ministry of MSME launched the 'Yashasvini Campaign' on 27.06.2024. The objective of the Campaign is to empower women entrepreneurs across India through various schemes on formalization, access to credit capacity building and mentorship through awareness generation about these schemes.
