PLASTIC PARKS

3054: SHRI DHARMENDRA YADAV: SHRI ARVIND GANPATSAWANT:

Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:

- (a) whether the Government proposes to set up plastic parks on the lines of medical devices parks, textile parks or electronic parks across the country, if so, the details thereof:S
- (b) the total number of parks set up State-wise including Uttar Pradesh, Maharashtra and Madhya Pradesh;
- (c) whether the Government provides grants for setting up plastic parks;
- (d) if so, the details of funds provided for the same to each State including the abovementioned States during the last five years;
- (e) whether the Government has received proposals from various States for setting up plastic parks; and
- (f) if so, the number of proposals received during the last five years, State-wise including the said States along with the action taken by the Government thereon?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS & FERTILIZERS (SMT. ANUPRIYA PATEL)

- (a):The Department of Chemicals and Petrochemicals implements a Scheme for Setting up of Plastic Parks under the New Scheme of Petrochemicals. Under this Scheme, the Government promotes setting up of need-based Plastic Parks with requisite infrastructure and enabling common facilities. The objective is to consolidate and synergize the capacities of downstream plastic processing industry to help increase investment, production and export in the sector as well as generate employment.
- (b) to (d): The Department has approved 10 Plastic Parks in different States of the country. The State-wise details of the approved Plastic Parks are at Annexure-I. Under the Scheme, the Government of India provides grant funding up to 50% of the project cost subject to a ceiling of Rs. 40 crore per project. The details of funds released to the Plastic Parks in the last five years, are at **Annexure**.
- (e) and (f): For the purpose of setting up Plastic Parks, the Department of Chemicals and Petrochemicals seeks preliminary proposals from State Governments, highlighting the

proposed location, financial details, broad cost estimates etc. Following in-principle approval from the Scheme Steering Committee, the State implementing agency is required to submit a Detailed Project Report (DPR) to the Department, which is evaluated and final approval is given by the Scheme Steering Committee based on the viability of the proposed project. Recently no proposal has been received from any State for setting up Plastic Parks.

In November, 2020, the Department invited proposals from the State Governments for establishing two new Plastic Parks. Proposals were received from the State Governments of Bihar, Uttar Pradesh (02 proposals), Karnataka and Himachal Pradesh. These were examined by an Expert Committee, based on which the setting up of Plastic Parks at Gorakhpur, Uttar Pradesh, and at Ganjimutt, Karnataka, was approved in July, 2022 and January, 2022 respectively.
