FINANCIAL SECURITY TO ANGANWADI WORKERS

†3169. SHRI BALWANT BASWANT WANKHADE:

Will the Minister of Women and Child Development be pleased to state:

- (a) the number of children under six years of age, pregnant women and lactating mothers registered in Anganwadi centres across the country, State-wise;
- (b) whether some State Governments including Maharashtra have requested the Union Government to increase the additional honorarium being given to those Anganwadi workers, who are holding additional charge of the nearby Anganwadi Centre;
- (c) if so, the details thereof, along with action taken by the Union Government in this regard;
- (d) whether the Union Government has also launched any insurance/social security scheme for the benefit of Anganwadi workers;
- (e) if so, the details of financial compensation given to Anganwadi workers under the said scheme; and
- (f) the number of Anganwadi workers benefited from the said scheme during each of the last three years and the current year, State-wise?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SAVITRI THAKUR)

(a) The total number of children under six years of age, pregnant women and lactating mothers registered in Anganwadi centres across the country, State/UT wise is placed at **Annexure I.**

(b) & (c) As per the mandate of Mission Saksham Anganwadi and Poshan 2.0, each Anganwadi Centre consists of one Anganwadi Worker (AWW) and one Anganwadi Helper (AWH) in the Main Anganwadi centre (AWC) and one Anganwadi Worker in the Mini AWC. Anganwadi Services under Mission Saksham Anganwadi and Poshan 2.0 is a Centrally Sponsored scheme. The Central Government is responsible for policy and planning and the State Governments are responsible for day-to-day program implementation. Government of India releases funds for providing honorarium to Anganwadi Workers (AWWs) and Anganwadi Helpers (AWHs) to the States/UTs as per the defined cost sharing ratio @Rs.4,500/- per month to AWW at main Anganwadi Centres (AWCs); @Rs.3,500/- per month to AWW at mini- AWCs and @Rs.2,250/- per month to AWH.

(d) to (f) Insurance benefits have been provided to all eligible Anganwadi Workers and Helpers under Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY) for life cover worth Rs.2.00 lakh (covers life risk, death due to any reason) in the age group of 18 to 50

years and under Pradhan Mantri Suraksha Bima Yojana for accidental cover of Rs.2.00 Lakh (accidental death and permanent full disability) /Rs.1.00 Lakh (partial but permanent disability) in the age group of 18-59 years. The number of anganwadi workers who have been covered in FY 2024-25 are placed at **Annexure II.**

During the interim budget Financial Year (FY) 2024-25 it was announced to extend healthcare annual coverage of Rs. 5 Lakhs under Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) to all Anganwadi workers and helpers. As per the information furnished by National Health Authority (NHA), Ayushman Cards have been generated for approx 8.15 Lakh Anganwadi Workers and Helpers for all States/ UTs except for States of Odisha, West Bengal and NCT of Delhi where the State Governments are not implementing AB-PMJAY. The State/UT wise details of beneficiaries covered under PM-JAY is placed at **Annexure III.**

The 'Pradhan Mantri Garib Kalyan Package (PMGKP), insurance scheme for Health Care Workers Fighting COVID-19' was launched on 30th March, 2020 to provide comprehensive personal accident cover of Rs.50 lakh to 22.12 lakh health care providers including community health workers and private health workers who may have been in direct contact and care of COVID-19 patients and may have been exposed to risk of being impacted.

64 claims of Anganwadi workers have been settled under the scheme and an amount of Rs. 32 crores has been disbursed @ Rs. 50,00,000/- per claim. The details of the total number of Anganwadi Workers covered under Pradhan Mantri Garib Kalyan Package State/ UT wise are placed at **Annexure IV**.
