†3778. DR. MANNA LAL RAWAT:

Will the Minister of MINORITY AFFAIRS be pleased to state:

(a) the number of minorities in the country, Religion and State-wise;

(b) whether the Government is aware that the people of Scheduled Tribes are taking advantage of the schemes of the Ministry of Minority Affairs as well as the Ministry of Tribal Affairs after conversion and if so, the details thereof;

(c) if not, whether the Government is contemplating to investigate this matter and take action against those illegally taking double benefits; and

(d) if so, the details thereof and if not, the reasons therefor?

ANSWER

THE MINISTER OF MINORITY AFFAIRS

(a) As per the information furnished by Office of the Registrar General India (RGI), the term "Minority" is not used in Census. However, the data on all religions as reported by the people of India are collected, tabulated and published in each Census. The last Census was conducted in 2011 and the state-wise populations based on religion are available at Annexure.

(b) to (d) All 3 Scholarship schemes for minorities are implemented through National Scholarship Portal(NSP) in which there is a provision of de-duplication of applicant under overall schemes, onboarded on NSP. Besides, a provision of One Time Registration (OTR) has also been introduced from 2024-25, which will further reduce the chances of duplicate beneficiaries among different Scholarship Schemes.
