ASSISTANCE TO SHGS UNDER PMFMEY

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) whether the Pradhan Mantri Formalisation of Micro Food Processing Enterprises Yojana (PMFMEY) has assisted 2.4 lakh Self Help Groups (SHGs) and sixty thousand individuals with credit linkages, if so, the details thereof;
- (b) whether any other scheme is complementing the efforts for reducing post-harvest losses and improving productivity and incomes and if so, the details thereof;
- (c) the steps taken/being taken by the Government for ensuring faster growth of the sector in this regard;
- (d) whether the Government would further promote private and public investment in the post-harvest activities including aggregation, modern storage, efficient supply chains, primary and secondary processing and marketing as well as branding and if so, the details thereof, State-wise including Andhra Pradesh, Telangana, Haryana and Uttar Pradesh; and
- (e) the steps taken/being taken to achieve the goal of Viksit Bharat by 2047 under such yojana?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

- (a). Under Centrally Sponsored- Pradhan Mantri Formalisation of Micro Food Processing Enterprises (PMFME) Scheme, Credit Linked Subsidy has been approved for 1,08,580 applicants which includes Individuals, Proprietorship firms, Partnership firms, Farmer Producer Organisations (FPOs), Non-Government Organisations (NGOs), Self Help Groups (SHGs), Co-operatives, Pvt. Ltd. Companies etc. In addition, seed capital assistance has been provided to 3,10,121 SHG members under the Scheme.
- (b) to (d). In order to promote and ensure overall development in the food processing sector, Ministry of Food Processing Industries (MoFPI) has been incentivizing setting up/expansion of related infrastructure through its Central Sector Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) Scheme, Production Linked Incentive Scheme for Food Processing Industry (PLISFPI) and Centrally Sponsored PM Formalization of Micro Food Processing Enterprises (PMFME) Scheme across the country. These schemes are not region or state specific but demand driven. These schemes aim to create modern infrastructure with efficient supply chain management from farm gate to retail outlet to give big boost to the growth of food processing sector in the country thereby helping in providing better returns to farmers, creating huge employment opportunities and reducing wastage of agricultural produce, increasing the processing level and enhancing the export of the processed foods.

The State-wise details of projects approved for financial support under these schemes in the country including the States of Andhra Pradesh, Telangana, Haryana and Uttar Pradesh till 31st October, 2024 are at **ANNEXURE**.

- (e). For achieving goals of 'Viksit Bharat by 2047', following provisions have been announced as a part of the Budget Announcement of 2024-25:
 - (i). Financial support for setting up of 50 multi-product food irradiation in the food processing sector.
 - (ii). Financial support for setting up of 100 food quality and safety testing labs with National Accreditation Board for Testing and Calibration Laboratories.
