SETTING UP OF MULTI-PRODUCT FOOD PROCESSING UNITS

3983. SMT. KAMLESH JANGDE:

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) the details of Cold Storage Scheme;
- (b) whether any time limit has been fixed for setting up multi product food processing units under Cold Chain and Value Addition Infrastructure or Cold Storage Scheme;
- (c) if so, the details and the intended outcomes thereof;
- (d) whether the Government has formulated any action plan for setting up of multi-product food processing units in the State of Chhattisgarh; and
- (e) if so, the details thereof and if not, the reasons therefor?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

(a). Department of Agriculture & Farmers Welfare has been implementing two schemes namely (i) Mission for Integrated Development of Horticulture (MIDH) and (ii) Capital Investment Subsidy for construction/ Expansion/ Modernization of Cold Storages and Storages for Horticulture through National Horticulture Board (NHB) for setting up of standalone cold storages across the country. Under MIDH scheme, financial assistance in the form of credit linked back ended subsidy is provided at the rate of 35% of the project cost in general areas and 50% of the project cost in hilly and scheduled areas through State Horticulture Missions. Under Capital Investment Subsidy for construction/ Expansion/ Modernization of Cold Storages and Storages for Horticulture, credit linked back ended subsidy is provided at the rate of 35% of the capital cost of the project in general areas and 50% in case of North East, hilly & scheduled areas for construction/ expansion/ modernization of cold storage and Controlled Atmosphere (CA) storage of capacity above 5000 MT and up to 10000 MT. In case of North East region, the units with capacity above 1000 MT are also eligible for assistance.

Ministry of Food Processing Industries (MoFPI) does not implement the Cold Storage scheme. However, MoFPI implements a component scheme namely Scheme for Integrated Cold Chain and Value Addition Infrastructure (Cold Chain scheme) under the Central Sector umbrella scheme- Pradhan Mantri Kisan Sampada Yojana (PMKSY) with an objective to provide integrated cold chain, preservation and value addition infrastructure facilities, without any break, from the farm gate to the consumer in order to reduce post-harvest losses of non-horticulture produce, dairy, meat, poultry, and marine /fish (except shrimp). Under the scheme, financial assistance in the form of grants-in-aid / subsidy is provided for setting up of cold chain project including multi product food irradiation units (integrated or standalone) at the rate of 35% of eligible project cost for project in General Area and @ 50% of eligible project cost for Difficult Areas as well as for projects of SC/ST, FPOs and SHGs, subject to maximum of Rs.10 crore per project.

(b) to (c). The timeline for completion and operationalization of cold chain projects including multiproduct food irradiation units is 24 months and 30 months in case of projects under general areas and difficult areas respectively as per the extant Cold Chain scheme guidelines.

Food irradiation units provide an effective alternate initiative to various food processing methodologies, by adding following benefits:

- Reduced post-harvest losses: (i) prevention/delay of sprouting and ripening, (ii) extension of shelf life and (iii) reduction of perishability of raw foods.
- Safety and sustainability: (i) non-polluting and eco-friendly process, (ii) reduction of carbon footprint of food value chain and (iii) free from toxic chemicals.
- Retains quality of produce: (i) no/ minimal effect on texture and nutrition and (ii) inactivate/ arrest growth of microorganisms.

The above benefits of food irradiation along with cold chain facility eventually lead to linking farmers to food processors and market through a well-equipped supply chain, thereby ensuring remunerative prices to farmers and year-round availability of food products to consumers across the country.

(d) to (e). Cold Chain scheme is demand driven and proposals are invited by the Ministry from across the country including the State of Chhattisgarh through floating Expression of Interests (EoIs) from time to time based on availability of funds under the scheme.
