PRODUCT IDENTIFIED IN RAJASTHAN UNDER PMFME

4023. SHRI DUSHYANT SINGH:

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) whether the Government has identified any product from the districts of the State of Rajasthan under "One District One Product" initiative of the Pradhan Mantri Formalization of Micro Food Processing Enterprises (PMFME) Scheme;
- (b) if so, the details thereof, specifically in Jhalawar-Baran district along with the details of current production of such products;
- (c) whether the Government has given any financial assistance to such districts to develop and produce quality products as identified;
- (d) if so, the details thereof along with the details of funds allocated under the said scheme for Rajasthan; and
- (e) the details of the steps taken/being taken by the Government to provide technical and financial aid/assistance to the producers?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

(a) & (b). Yes, Sir. Ministry of Food Processing Industries (MoFPI) in its Centrally Sponsored "Pradhan Mantri Formalisation of Micro food processing Enterprises (PMFME)" Scheme follows One District One Product (ODOP) approach. ODOP has been identified for 33 districts of Rajasthan. Orange based and Garlic based products has been approved as the ODOP for the district of Jhalawar and Baran respectively. The District-wise list of ODOP for the State of Rajasthan, including Jhalawar- Baran district, is at **ANNEXURE-I**. Under Credit-Linked Subsidy, no loan for micro food processing enterprises has been sanctioned for Orange based products (ODOP) in the district of Jhalawar. However, 5 loans for micro food processing enterprises have been sanctioned in Garlic based products (ODOP) in the district (ODOP) in the district of Baran.

(c) to (e). In Baran District, total 13 loans have been sanctioned with approved subsidy of Rs. 02.41 crore and total 10 loans have been sanctioned with approved subsidy of Rs. 01.61 crore in Jhalawar District. Under the PMFME Scheme, financial, technical and business support is provided for upgradation of micro food processing enterprises in the country. The Scheme is operational from FY 2020-21 to 2025-26 with an outlay of Rs. 10,000 Crore. The scheme aims to enhance the competitiveness of existing individual micro-enterprises in the unorganized segment of the food processing industry and promote formalization of the sector. The details of assistance offered to the prospective entrepreneurs under various components of the Scheme, along with eligible entities under PMFME Scheme, are at **ANNEXURE-II**. An amount of Rs 43.95 Cr. has been released to the State of Rajasthan till 31st October, 2024 for implementation of various components of the Scheme.

The details of assistance available to Micro Food Processing Enterprises under PMFME Scheme

- (i). Support to Individual / Group Category Micro Enterprises: Credit-linked capital subsidy @35% of the eligible project cost, maximum ceiling Rs.10 lakh per unit;
- (ii). Support to SHGs for seed capital: Seed capital @ Rs. 40,000/- per member of SHG engaged in food processing for working capital and purchase of small tools subject to maximum of Rs. 4 lakh per SHG Federation.
- (iii). Support for Common Infrastructure: Credit linked capital subsidy @35% subject to maximum of Rs. 3 crore to support FPOs, SHGs, Cooperatives and any Government agency for setting up of common infrastructure. The common infrastructure will also be available for other units and public to utilize on hiring basis for substantial part of the capacity.
- (iv). Branding and Marketing Support: Grant upto 50% for Branding and Marketing to groups of FPOs/ SHGs/ Cooperatives or an SPV of micro food processing enterprises.
- (v). Capacity Building: The scheme envisages training for Entrepreneurship Development Skilling (EDP+): program modified to meet the requirement of food processing industry and product specific skilling.
