### TAX EXEMPTIONS FOR MSME SECTOR

4043. PROF. SOUGATA RAY:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the details of new enterprises registered in MSME Sector since the last three years, State wise;
- (b) the details of employment generated through such enterprises/units; and
- (c) whether the Government has any proposal to uniform the tax exemptions, other relaxations on electricity bill, water bill, environment clearances through single window facilities, if so, the details thereof?

- (a) & (b): The details of new enterprises (MSMEs) incorporated in the last three years, State/UTs-wise and the employment generated through such enterprises as per the Udyam Registration Portal (URP), are given at Annexure.
- (c): As informed by the Department for Promotion of Industry and Internal Trade (DPIIT), it has developed the National Single Window System (NSWS) portal, which integrates the existing clearance systems of various Ministries/ Departments of Government of India and State Governments. A total of 277 Central approvals and 2,977 state approvals can be applied through this single window facility.
