## GOVERNMENT OF INDIA MINISTRY OF JAL SHAKTI DEPARTMENT OF DRINKING WATER & SANITATION LOK SABHA UNSTARRED QUESTION NO. 4068 ANSWERED ON 19.12.2024

### DRINKING WATER AND SANITATION FACILITIES

#### †4068. SHRI BALWANT BASWANT WANKHADE:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) whether the Government has set a target of providing drinking water and sanitation facilities in all schools of the country by the end of March, 2025;
- (b) if so, the details thereof along with the targets achieved in this regard and if not, the reasons therefor, State-wise;
- (c) the number of schools without the facility of drinking water and sanitation, State-wise;
- (d) whether the Government has any plan to set new target in this regard and if so, the details thereof;
- (e) whether the Union Government has received any proposals from the States in this regard during 2024-25 and if so, the details thereof; and
- (f) the number of proposals approved and financial assistance provided for the said purpose, Statewise?

#### ANSWER

### MINISTER OF STATE FOR JAL SHAKTI (SHRI V. SOMANNA)

(a) to (d) Since August 2019, Government of India in partnership with States is implementing Jal Jeevan Mission (JJM) – Har Ghar Jal to make provision of potable water to every rural household of the country, through functional tap water connection i.e. at a service level of 55 litre per capita per day (lpcd), of prescribed quality (BIS:10500), on regular and long-term basis.

Department of School Education and Literacy, Ministry of Education, Government of India implements a Centrally Sponsored programme, Samagra Shiksha Scheme to support creation of infrastructure and basic facilities including Drinking Water and Sanitation facilities for students in Government Schools.

Ministry of Education has informed that based on their requirements and priorities, at the beginning of every year, States/ UTs prepare their Annual Work Plan and Budget (AWP & B) in accordance with the guidelines issued by the Ministry of Education. These plans are then

appraised/ approved by Project Approval Board (PAB) in consultation with States/ UTs as per the programmatic and financial norms of the Scheme and availability of budgetary resources. The State/ UT-wise details of schools with and without drinking water & toilet facilities are at **Annex - I**.

(e) & (f) As stated above, States prepare and submit their proposals for consideration of the PAB in Ministry of Education. As informed by Ministry of Education, the State/UT wise details of Drinking water and Sanitation facilities approved during 2024-25 along with financials are at **Annex-II.**
