GROWTH OF FOOD PROCESSING SECTOR

4076. SMT. BHARTI PARDHI:

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) whether the Government is creating state of the art infrastructure to support the growth of the food processing sector;
- (b) if so, the details thereof along with the financial assistance provided to each State particularly to Madhya Pradesh during the last three years and the current financial year;
- (c) whether the Government has launched "One District, One Product" initiative;
- (d) if so, the nature of products selected and the assistance provided to the individuals and groups under the said initiative;
- (e) the details of the financial assistance provided to the States by the Government under the said initiatives, State-wise particularly of Madhya Pradesh;
- (f) whether all the districts of Madhya Pradesh have been covered under the said initiative; and
- (g) if so, the details thereof and if not, the reasons therefor?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

(a). Yes, Sir. In order to promote and ensure overall development / growth of the food processing sector in the country, Ministry of Food Processing Industries (MoFPI) has been incentivizing setting up/expansion of related infrastructure through its Central Sector schemes namely Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) Scheme, Production Linked Incentive Scheme for Food Processing Industry (PLISFPI) and Centrally Sponsored – Pradhan Mantri Formalization of Micro Food Processing Enterprises (PMFME). These schemes are not region or state specific but demand driven.

(b). Ministry extends financial support to prospective entrepreneurs for setting up of different kinds of food processing industries as per respective scheme guidelines. Being central sector schemes, no statewise budget allocation is done under PMKSY & PLISFPI. Year-wise total allocation & funds utilized under PMKSY & PLISFPI since 2021-22 and State/UT wise funds (Central Share) released under PMFME schemes since 2021-22 are at **ANNEXURE-I**.

(c) to (e). PMFME Scheme primarily adopts One District One Product (ODOP) approach to reap the benefit of scale in terms of procurement of inputs, availing common services and marketing of products. It provides the framework for value chain development and alignment of support infrastructure.

The ODOP are identified by States / UTs based on the agriculture production, raw material availability, perishability of the product etc. ODOP has been approved in 726 Districts of 35 States/UTs. As soon as, the States/ UTs recommends the ODOP for districts, the same are approved under the PMFME

scheme. The funds (Central share) released to States/UTs including Madhya Pradesh for implementation of various components of PMFME scheme is at **ANNEXURE-I.**

(f) & (g). ODOP has been approved in 52 districts of Madhya Pradesh. The district-wise details of approved ODOP in state of Madhya Pradesh is at **ANNEXURE-II.**
