# LOK SABHA UNSTARRED QUESTION NO. 4184 TO BE ANSWERED ON 20.12.2024

#### SWADHAR GREH SCHEME

4184. SHRI GYANESHWAR PATIL: SMT. DELKAR KALABEN MOHANBHAI:

Will the Minister of Women and Child Development be pleased to state:

- (a) the details of the funds allocated, released and utilized in the various States of the country under the Swadhar Greh scheme since its introduction, State-wise;
- (b) the number of the Swadhar Greh set up in Dadra & Nagar Haveli and Madhya Pradesh under the said scheme, district-wise;
- (c) the number of beneficiaries under the said scheme, State-wise including Dadra & Nagar Haveli and Madhya Pradesh; and
- (d) the number of non-governmental organizations and Self Help Groups that collaborated with the Government for the implementation of the said scheme in the country, State-wise particularly Dadra & Nagar Haveli and Madhya Pradesh?

#### **ANSWER**

MINISTER OF STATE IN THE MINISTRY OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SAVITRI THAKUR)

(a) to (d) Under the overarching 'Mission Shakti', erstwhile schemes of 'Swadhar Greh' for women in difficult circumstances and 'Ujjawala Home' for Prevention of Trafficking, have been merged and known as 'Shakti Sadan Scheme', which is an Integrated Relief and Rehabilitation Home for women in distressful situations including trafficked women. It aims at creating a safe and enabling environment for the women in such difficult situations, to enable them to overcome the adverse circumstances.

The Shakti Sadan Scheme is a demand driven Centrally Sponsored Scheme, under which funds are directly released to the States/UTs for implementation of the scheme. The States/UTs assess their requirement as per local needs and proposals are approved by the Programme Approval Board (PAB) after discussion with States/UTs. Under the Scheme, financial assistance is provided for running of Shakti Sadan in rented premises.

The funds released during the last three financial years period with regard to Shakti Sadan is at **Annexure-I.** The District-wise number of functional Shakti Sadan in Dadra and Nagar Haveli and Madhya Pradesh is at **Annexure II.** State/UT-wise number of women benefiting under Shakti Sadan Scheme at present including Dadra & Nagar Haveli and Madhya Pradesh is at **Annexure III**.
