#### NATIONAL HEALTH MISSION IN CHHATTISGARH

#### †4203. SHRI BHOJRAJ NAG:

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) the amount of funds allocated and utilized in Chhattisgarh since the introduction of National Health Mission till date;

(b) whether any concrete scheme/plan has been formulated to make the said Mission more effective and for allocation of more funds;

(c) if so, the details thereof; and

(d) the number of the health centres set up in Chhattisgarh under the said mission?

### ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI PRATAPRAO JADHAV)

(a) to (d): Under National Health Mission (NHM), Government provides technical and financial support to the States/UTs for improvement in health infrastructure and strengthening healthcare systems. The details of central release and expenditure to the State of Chhattisgarh under NHM from the FY 2013-14 to FY 2024-25 is as follows:
