729. Dr. Rajkumar Sangwan:

Will the Minister of AYUSH be pleased to state:

- a) the total number of Ayurveda, Yoga, Naturopathy Siddha and Homoeopathy (AYUSH) colleges and hospitals in the country along with the seats available therein, State/ UT-wise and stream-wise;
- b) the details of the provisions criteria made for admission of the Scheduled Cast/ Scheduled Tribes and other economically weaker sections of the society in these colleges;
- whether the Government has received such proposals from Government of various States/UTs including Uttar Pradesh and private companies for setting up of more such colleges and hospitals;
- d) if so, the details thereof along with the action taken by the Government on such proposals;
- e) whether the graduate level degree awarded by these colleges are equivalent to the degrees awarded by the medical colleges in the State; and
- f) if so, the details thereof and if not, the reasons therefor?

- (a) The details of Ayurveda, Yoga, Naturopathy Siddha and Homoeopathy (AYUSH) colleges and hospitals in the country along with the seats available therein, State/ UT-wise and stream-wise are placed at Annexure- I.
- (b) The details of the provisions criteria made for admission of the Scheduled Caste/Scheduled Tribes and other economically weaker sections of the society in these colleges are placed at Annexure-II.
- c) & d) The details of the proposals received from various State/UT Governments including Uttar Pradesh and private companies for setting up of more colleges and hospitals along with the action taken by the Government on such proposals are placed at Annexure-III.

e) & f) The graduate level degree awarded by Ayurveda, Siddha and Homoeopathy colleges are equivalent to the degrees awarded by the medical colleges in the State.

Under the provisions of the NCISM Act, 2020 and NCH Act, 2020, at graduate level the degree awarded in respect of Indian System of Medicine and Homoeopathy respectively are as:

- (i) Ayurveda: Bachelor of Ayurvedic Medicine and Surgery (B.A.M.S.)
- (ii) Siddha: Bachelor of Siddha Medicine and Surgery (B.S.M.S.)
- (iii) Homoeopathy: Bachelor of Homoeopathic Medicine and Surgery (B.H.M.S.)

Details of the provisions criteria made for admission of the Scheduled Caste/ Scheduled Tribes and other economically weaker sections of the society in Ayurveda, Siddha and Homoeopathy colleges are as follows:

Admission of candidates belonging to Schedule Caste/ Schedule Tribes and other economically weaker sections(Gen-EWS) to undergraduate(UG) and postgraduate(PG) courses under Ayurveda, Siddha and Homoeopathy streams shall be made as per the provisions of regulations laid under the NCISM/NCH Act 2020.

- (1). Central Reservation Policy for admission to All India Quota (AIQ)-UG&PG seats under Govt./Govt. Aided/National Institutes/Central Universities of Ayurveda, Siddha and Homoeopathy streams in respect of Scheduled Caste / Schedule Tribes and other economically weaker sections (Gen-EWS) as follows:
 - Schedule Caste(SC)- 15%
 - Schedule Tribe(ST)- 7.5%
 - Economically Weaker Sections (Gen-EWS) 10%

(2). Eligible criteria to appear NEET (UG) for Admission to Undergraduate courses of Ayurveda, Siddha and Homoeopathy.

- (a) There shall be a uniform National Eligibility-cum-Entrance Test for admission to the undergraduate courses for Admission in Undergraduate Ayurveda, Siddha and Homoeopathy courses. The relevant regulations under NCISM/NCH Act 2020 regarding the Eligibility criteria to appear NEET (UG), and NEET (UG) eligibility criteria for Admission in Undergraduate Ayurveda, Siddha and Homoeopathy courses are as follows:
 - i. National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Ayurveda Education) Regulations-2022
 - ii. National Commission for Indian System of Medicine (Minimum Standard of Undergraduate Siddha Education) Regulations, 2022.
 - iii. National Commission for Homoeopathy (Homoeopathy Graduate Degree Course Bachelor of Homoeopathic Medicine and Surgery (B.H.M.S). Regulations- 2022.
- (b) The details of qualifications required to appear NEET (UG) for admission to Ayurveda, Siddha and Homoeopathy -UG courses under different categories are as follows:
 - (a) For Ayurveda and Siddha UG Courses -Candidate must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology at the 10+2 or equivalent examination in the case of general category and 40% Marks in the case of the Scheduled Castes, Scheduled Tribes, and Other Backward Classes.

- **(b) For Homeopathy-UG Course** Candidate must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology/Biotechnology at the 10+2 or equivalent examination in the case of general category and 40% Marks in the case of the Scheduled Castes, Scheduled Tribes, and Other Backward Classes.
- (c) In respect of persons with disability as specified under the Rights of Persons with Disabilities Act, 2016 (49 of 2016), the minimum qualifying marks in the said qualifying examination are as follows: a) shall be 45% in the case of the general category. b) 40% in the case of the Scheduled Castes, Scheduled Tribes and Other Backward Classes.

(c) NEET (UG) Eligible criteria for Admission in Undergraduate courses under Ayurveda, Siddha and Homoeopathy stream.

In order to consider for admission to the undergraduate programme for an academic year, it shall be necessary for a candidate to obtain minimum of marks at the 50th percentile in the National Eligibility-cum-Entrance Test for the undergraduate programme held for the said academic year:

Provided that in respect of,-

- (i) candidates belonging to the Scheduled Castes, Scheduled Tribes and Other Backward Classes, the minimum marks shall at the 40th percentile;
- (ii) (candidates with specified disabilities under the Rights of Persons with Disabilities Act, 2016 (49 of 2016) the minimum marks shall be at 45th percentile in the case of general category and 40th percentile in the case of the Scheduled Castes, Scheduled Tribes and Other Backward Classes.

(3). Eligible criteria for Admission to Post Graduate courses under Ayurveda, Siddha and Homoeopathy stream:

- (a) There shall be a uniform Post-Graduate National Entrance Test (AIAPGET) for admission to postgraduate courses under Ayurveda, Siddha and Homoeopathy streams. The relevant regulations under NCISM/NCH Act 2020 regarding the AIAPGET eligibility criteria for Admission in postgraduate Ayurveda, Siddha and Homoeopathy courses are as follows:
 - i. The National Commission for Indian System of Medicine (Minimum Essential Standards, Assessment and Rating for Postgraduate Institutions and Minimum Standards for Postgraduate Education in Ayurveda) Regulations, 2024.
 - ii. The National Commission for Indian System of Medicine (Minimum Essential Standards, Assessment and Rating for Postgraduate Institutions and Minimum Standards of Postgraduate Siddha Education) Regulations, 2024.

- iii. The National Commission for Homoeopathy (Homoeopathy Post-Graduate Degree Course- Doctor of Medicine in Homoeopathy) Regulations, 2024.
- (b) The details of AIAPGET eligibility criteria for admission to Ayurveda, Siddha and Homoeopathy -PG courses under different categories are as follows:

In order to be eligible for admission to Postgraduate degree programme for an academic year, it shall be necessary for a candidate to obtain minimum of marks at 50th percentile in the 'Postgraduate National Entrance Test' held for the said academic year.

Provided that in respect of:

- i. For candidates belonging to the Scheduled Castes, Scheduled Tribes and Other Backward Classes, the minimum marks shall be at the 40th percentile.
- ii. (candidates with specified disabilities under the Rights of Persons with Disabilities Act, 2016 (49 of 2016) the minimum marks shall be at 45th percentile in the case of general category and 40th percentile in the case of the Scheduled Castes, Scheduled Tribes and Other Backward Classes

Details of proposals received from Government of various States/UTs and private companies for setting up of Ayurveda, Yoga & Naturopathy, Siddha and Homoeopathy colleges and hospital along with action taken by the government on proposal during academic year 2024-25 are as follows:

A) The establishment of new AYUSH Colleges in the country comes under the purview of respective State/UT Governments including Uttar Pradesh. However, under the Centrally Sponsored Scheme of National AYUSH Mission (NAM), there is a provision of financial assistance to the State/UT Governments for the establishment of new AYUSH Colleges in the States where availability of Ayush teaching institutions is inadequate in Government Sector. Accordingly, State/UT Governments including Uttar Pradesh may avail eligible financial assistance by submitting the suitable proposals through State Annual Action Plans (SAAPs) as per the provision of NAM guidelines. Status of financial assistance provided to State /UT Governments including Uttar Pradesh for establishment of new Ayush Educational Institutions under NAM is furnished as follows:
