AMOUNT ALLOCATED BY COMPANIES UNDER CSR IN ANDHRA PRADESH QUESTION

* 100. SHRI PUTTA MAHESH KUMAR:

Will the Minister of CORPORATE AFFAIRS be pleased to state:

- (a) the total number of companies registered, presently functional, dormant and struck off during the last five years across Andhra Pradesh, districtwise, especially in Eluru district along with their details;
- (b) the list of CSR initiatives undertaken and beneficiaries of the same at present in Andhra Pradesh, district-wise, especially in Eluru district;
- (c) the total funds allocated, sector-wise by companies for CSR activities in Andhra Pradesh during the last five years, district-wise, especially in Eluru district;
- (d) whether the Government has considered increasing the financial criteria of allocating 2% of average net profits of companies; and
- (e) if so, the details thereof and if not, the reasons therefor?

- (a): The details of total number of companies registered, presently functional, dormant and struck off during the last five years across Andhra Pradesh including Eluru district is at Annexure-I.
- (b): On the basis of the filings made by the companies in the MCA21 registry, district-wise CSR expenditure in Andhra Pradesh during last three Financial Years (FY) from 2018-19 to 2022-23 is at Annexure II. The beneficiary-wise details of CSR expenditure is not maintained.
- (c): There is no provision of allocation of CSR funds under CSR legal framework. However, on the basis of the filings made by the companies in the MCA21 registry, sector-wise CSR expenditure in Andhra Pradesh during the last five financial years (FYs) from 2018-19 to 2022-23 is attached at Annexure-III.
- (d) & (e): No such proposal has been considered by the Government as the extant provisions are considered appropriate.
