STATEMENT REFERRED TO IN REPLY TO PARTS (A) & (B) IN RESPECT OF LOK SABHA STARRED QUESTION NO. 122 FOR ON 13.02.2025 REGARDING REPLY PERFORMANCE OF AIRLINES ASKED BY MS MAHUA MOITRA. (a) The airline wise On Time Performance (OTP) of major scheduled domestic airlines submitted by four metros airports (i.e. Delhi, Mumbai, Bangalore and Hyderabad) to DGCA (Directorate General of Civil Aviation) month wise for the year 2024 is placed at Annexure. During the last 3 years i.e. from Jan 2022 to till date, there has been only one accident to aircraft involving scheduled airlines. To ensure the safe operation of aircraft, DGCA has a robust mechanism in place wherein the compliance of safety regulations are constantly monitored through surveillances, spot check and regulatory audits. addition special audits are also carried out as per the risk perceived. Findings of audits, surveillances and spot checks are followed up with the concerned operator for compliance. The observations are closed after due verification. Further the compliance of the action taken by the operator is verified during the next audit/surveillance. In case of any violations/non-compliance to regulations detected during audit/surveillance, enforcement action including financial penalty is imposed by the DGCA.
