(a) the details of India's agricultural export performance in the last five years highlighting the role of Maharashtra in this regard;

(b) the details of percentage of India's total agricultural exports contributed by Maharashtra and the extent to which this percentage evolved during the last decade;

(c) whether the Government has taken any steps to promote the export of agricultural products from the country particularly Maharashtra for high demand crops and if so, the details there of;

(d) whether the Government is planning to provide schemes or incentives to farmers particularly Maharashtra's farmers to encourage export-oriented farming and if so, the details thereof;

(e) the details of current infrastructure such as cold storage and logistics support available in Maharashtra to support agricultural exports; and

(f) whether the Government proposes to set up new export processing zones or agri-export clusters in the country particularly Maharashtra to facilitate agricultural exports and if so, the details thereof?

STATEMENT IN RESPECT OF PARTS (a) TO (f) OF THE LOK SABHA STARRED QUESTION NO. 178 FOR 11TH MARCH, 2025 REGARDING "AGRICULTURAL EXPORT PERFORMANCE".

(a) & (b): The Central Government maintains validated record of total Agricultural exports from India. India's export of agricultural products in last decade along with Maharashtra share is as follows:

(c) to (f): Agricultural and Processed Food Products Exports Development Authority (APEDA), an export promotion body, was established by Government under the Ministry of Commerce and Industry to undertake the development and promotion of export of various products including fruits, vegetables and their products. The Department of Commerce through APEDA provides financial assistance to member exporters of APEDA from across the country under Agriculture and Processed Foods Export Promotion Scheme of APEDA for the 15th Finance Commission Cycle (2021-22 to 2025-26) in the following three broad areas:

- 1. Scheme for Quality Development
- 2. Scheme for Market Promotion
- 3. Scheme for infrastructure Development
- Quality Development: Assistance is provided to food processing units to adopt global standards, upgrade food testing labs and acquire higher precision equipment etc.
- Market Promotion- The assistance covers participation of exporters in international trade fairs, organizing buyer seller meets, developing packaging standards for new products, and upgrading the existing standards.

Efforts are being made by APEDA to establish Maharashtra's major agricultural products, such as mangoes, pomegranates, grapes, and oranges, in international markets. Indian mangoes have gained a strong presence in the US, South Korea, and Japan, while exports of pomegranates and mangoes are expanding to Australia. Additionally, oranges are being exported to Muscat, and grapes to China.

3. **Development of export infrastructure** - Support is provided for developing and strengthening the cold chain network for perishable products, integrated packhouses compliant with global norms and advanced equipment/machinery at export facilities meeting the importing country requirements.

APEDA has funded various infrastructure projects in Maharashtra, including common packhouses for mangoes, pomegranates, bananas, and oranges in districts like Ratnagiri, Jalna, and Wardha. Other projects include cold storage, irradiation facilities, and export centres for horticultural products in Mumbai, Navi Mumbai, Nashik, and Pune. These initiatives aim to enhance the export capacity of fresh produce from the region.

APEDA is empowering farmers to promote export-oriented farming. In 2023-24, over 1,000 Farmer Producer Organizations (FPOs) were registered as exporters, and APEDA has set up an online portal to connect FPOs with international buyers. APEDA conducted 270 training programs in 2023-24, benefiting over 23,000 individuals, including farmers and exporters in Maharashtra. These programs focused on export certifications, organic farming, and best practices to improve export quality.

In addition to financial assistance provided by APEDA, the Government of India through Ministry of Food Processing & Industries (MoFPI) also provides assistance/support for infrastructure and cold storage under Scheme such as "Operation Green" and "Integrated Cold Chain and Value Addition Infrastructure (Cold Chain)". The details of Cold Storage set up under the schemes of Operation Green and Cold Chain in the state of Maharashtra are as under:

Additionally, the Department of Agriculture and Farmers Welfare (DA&FW) is implementing the Mission for Integrated Development of Horticulture (MIDH) for the holistic development of the horticulture sector under which financial assistance is available to various horticulture activities like creation of cold storage facilities for reducing post-harvest losses and enhancing market access. Under this initiative, financial assistance has been provided for setting up of 665 cold storage facilities in Maharashtra with a total capacity of 12,19,851 metric tonnes.

Further, Department of Agriculture and Farmers Welfare (DA&FW) is implementing Horticulture Cluster Development Programme for selected high value horticulture crops through National Horticulture Board (NHB). This Programme is designed to leverage the geographical specialization of horticulture clusters and promote integrated and market led development of pre-production, production, post-harvest, logistics, branding, export oriented and marketing activities. So far, 15 clusters have been identified on pilot basis. Under these clusters, Nashik District for Grapes, Solapur for Pomegranate and Jalgaon for Banana have been identified in Maharashtra.

The Government of India has implemented measures to safeguard the interests of soybean and onion farmers in the country including in Maharashtra, which is a significant producer of these two commodities. These include an increase in the import duty of 20% on crude and refined edible oils (such as soybean oil, palm oil, and sunflower oil). Additionally, the export duty on onions has been reduced from 40% to 20%, and the Minimum Export Price (MEP) on onions has been abolished.
