Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) the detailed data on the funds sanctioned and disbursed under the Rashtriya Krishi Vikas Yojana (RKVY)- Remunerative Approaches for Agriculture and Allied sector Rejuvenation (RAFTAAR) during the last three years;
- (b) the detailed data on the number of beneficiaries under the RKVY-RAFTAAR during the same period;
- (c) the steps taken by the Government to mitigate risks of farmers with a focus on additional income generation activities under the scheme;
- (d) whether any training initiatives were carried out under the scheme; and
- (e) if so, the details thereof and if not, the reasons therefor?

(a) to (e): A statement is laid on the Table of the House.

STATEMENT IN RESPECT OF PARTS (a) TO (e) OF THE LOK SABHA STARRED QUESTION NO.180 FOR 11.03.2025 REGARDING 'DATA ON RKVY-RAFTAAR'.

(a): Till the year 2021-22, Rashtriya Krishi Vikas Yojana - Remunerative Approaches for Agriculture and Allied Sector Rejuvenation (RKVY-RAFTAAR) was implemented as a standalone scheme for the DPR projects. From 2022-23 onwards, 7 other schemes namely Per Drop More Crop(PDMC), Rainfed Area Development(RAD), Sub-Mission on Agriculture Mechanization (SMAM) including Management of Crop Residue (CRM), Soil Health and Fertility (SH&F), Paramparagat Krishi Vikas Yojana (PKVY), Agro-Forestry & Crop Diversification Programme (CDP) were merged with DPR component of RKVY. Now the scheme has been renamed as Pradhan Mantri - Rashtriya Krishi Vikas Yojana (PM-RKVY).

Details of allocation and release under the during the last three years are as under:

(b): RKVY-RAFTAAR supports individuals as well as community and institutional assets. Details of direct and indirect beneficiaries are not maintained centrally.

(c): Under PM-RKVY, Rainfed Area Development (RAD) beneficiaries are provided support for integrated farming system at unit cost of Rs. 30,000/year for providing sustainable agricultural practices that are resilient to climate change. The beneficiaries are encouraged to adopt mixed cropping practices with allied activities like horticulture, livestock, fishery, plantation, apiculture etc. to enable them in maximizing the farm returns and in enhancing their income.

(d) & (e): In last 3 years, DPR based capacity building programmes were approved under PM-RKVY, the details of which is enclosed at Annexure-I. These initiatives focus on improving productivity, technology adoption and entrepreneurship among farmers and rural youth.

In addition, each component scheme has small trainings inbuilt like need based training on farm mechanization/soil health card/organic farming activities/micro irrigation/quality seed production etc.
