#### MSME SCHEMES FOR SETTING UP OF ENTERPRISES

### \*211. SMT. BHARTI PARDHI: SHRI OMPRAKASH BHUPALSINH ALIAS PAVAN RAJENIMBALKAR:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether the Government has any scheme to assist common man to set up an enterprise by utilizing soft loans, if so, the details thereof;
- (b) whether the said scheme is effective for rural people, if so, the details thereof;
- (c) the details of the schemes being implemented by the Ministry and the amount of funds allocated and utilized thereunder during the last three years particularly in Madhya Pradesh and the aspirational district of Osmanabad;
- (d) whether the schemes for MSME sector have contributed to increase the number of start-ups in the country and if so, the details thereof;
- (e) the details of various schemes available for setting up of a start-up/business; and
- (f) the details of the employment generated through said schemes during the last three years, State-wise?

#### **ANSWER**

## MINISTER OF MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI JITAN RAM MANJHI)

(a) to (f): A statement is laid on the table of the House.

## STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (f) OF THE LOK SABHA STARRED QUESTION No. †\*211 FOR ANSWER ON 13.03.2025

- (a) to (c): Government is implementing the following major Central sector schemes with focus on rural areas for providing financial support to common man to set up an enterprise:
  - (i)\_Prime Minister's Employment Generation Programme (PMEGP): Prime Minister's Employment Generation Programme (PMEGP) is a Scheme for assisting entrepreneurs in setting up of new enterprises in the non-farm sector. Under PMEGP, beneficiaries can avail of Margin Money (MM) subsidy ranging from 15% to 35% based on various geographical and demographical criteria.

Since inception i.e., FY 2008-09 till FY 2024-25 (as on 10.03.2025), around 7.98 lakh micro enterprises have been assisted in rural areas under PMEGP with Margin Money subsidy of Rs. 22,506.4 Crore. Area-wise Performance of PMEGP in rural and urban areas during the last three years and current financial year i.e. FY 2024-25 (up to 10.03.2025) is given at **Annexure I**.

Prime Minister's Employment Generation Programme being a Central sector scheme, no State wise allocation of budget is done. Funds are utilised based on the demand generated and loans sanctioned by the financial institutions. Margin Money (MM) subsidy disbursed and number of units assisted in Madhya Pradesh and the Aspirational district of Osmanabad during the last three years is given at **Annexure II**.

- (ii) PM Vishwakarma: PM Vishwakarma is a holistic scheme to provide end-to-end support to traditional artisans and craftspeople who work with their hands, using tools, in the 18 trades covered. The scheme provides the following benefits:
  - i. Recognition through PM Vishwakarma Certificate and ID Card
  - ii. Skill Upgradation
  - iii. Toolkit Incentive
  - iv. Credit Support
  - v. Incentive for Digital Transactions
  - vi. Marketing Support

As PM Vishwakarma is a Central Sector Scheme, State-wise funds are not allocated. Since its launch, as on 10.03.2025, 2.67 lakh applications from Madhya Pradesh State have been successfully registered, and the scheme benefits have been initiated. Further 2,665 applications from Dharashiv, Maharashtra have been successfully registered, and the scheme benefits have been initiated.

(d) to (e): Government with an intent to build a strong ecosystem for nurturing innovation, startups and encouraging investments in the startup ecosystem of the country launched the 'Startup India' initiative by the Department for Promotion of Industry and Internal Trade (DPIIT) on 16th January 2016. Till 31<sup>st</sup> January 2025, 1,61,150 entities have been recognised as startups by DPIIT.

Under the Startup India initiative, the Government is implementing three Schemes, namely, Fund of Funds for Startups (FFS), Startup India Seed Fund Scheme (SISFS) and Credit Guarantee Scheme for Startups (CGSS) to support startups across categories and sectors at various stages of their business cycle.
