**(a) to (e): The Ministry of Labour & Employment (MoLE) has signed an MoU with APNA, one of India’s leading job recruitment platforms to enhance employment prospects for job seekers. Job seekers on NCS will gain broader employment options across metro and non-metro cities. It will promote equal opportunities for all including women and persons with disabilities, ensuring a fair recruitment process. This initiative aligns with NCS’s mission to create a dynamic, inclusive job ecosystem, helping job seekers from all backgrounds find suitable opportunities.**

**This collaboration marks a significant step in bridging the gap between talent and employment, fostering economic growth and workforce development in India. This partnership will bring over 10 lakh job opportunities annually to the National Career Service (NCS) Portal, strengthening domestic employment avenues.**

**APNA and other MoU partners will be able to access the data of candidates who have applied and also those who have not applied but are eligible for that post. National Career Services has implemented necessary measures to ensure that the data security is in compliance with MeITy guidelines.**
