- (c) the manner in which these old Bhawans would be used in the future and their maintenance would be carried out; and**
- (d) the details of total expenditure budgeted and sanctioned for the whole project, year-wise?**

**STATEMENT REFERRED TO IN REPLY TO PARTS (a) to (d) OF THE LOK SABHA STARRED QUESTION NO. 283 FOR ANSWER ON 20<sup>th</sup> MARCH 2025 REGARDING COMMON CENTRAL SECRETARIAT BUILDING.**

**(a) to (d) Construction of common Central Secretariat Buildings 1, 2, 3 & 10 along the Kartavya Path is underway. The schedule for completion is as follows:**

- I. Common Central Secretariat Building-3: 30.04.2025**
- II. Common Central Secretariat Building-1: 30.06.2025**
- III. Common Central Secretariat Building-2: 30.07.2025**
- IV. Common Central Secretariat Building-10: 30.04.2026**

**After completion of the buildings, statutory clearances for occupancy, including fire clearance will be obtained and thereafter these buildings will be put to use for locating various ministries/departments. The future use of the vacated office buildings will be notified in due course.**
