- (a)the details of the Centrally Sponsored Schemes (CSS) being implemented by the Government for the welfare of labourers and workers in Maharashtra and Dadra and Nagar Haveli during the last five years and the current year;
- (b)the details of the funds allocated, sanctioned, released and utilised for each of the said schemes during the last five years and the current year, year and scheme-wise;
- (c)the details of the number of workers benefitted from the said schemes in Maharashtra and Dadra and Nagar Haveli during the said period, year-wise;
- (d)whether the Government has found any shortcomings in the implementation of the said schemes; and
- (e)if so, the manner in which the Government has addressed the said shortcomings?

(a) to (e): The schemes of Ministry of Labour and Employment are Central Sector schemes. Major welfare schemes being implemented are (i) Pradhan Mantri Shram Yogi Maandhan (PMSYM), a voluntary contributory scheme with matching contribution by Government of India for old age pension; (ii) Labour Welfare Scheme (LWS) for welfare of Beedi / Cine / Non-Coal Mine workers and their family members covering three components viz. Health, Scholarship and Housing; (iii) National Career Service (NCS) for establishment of Model Career Centres (MCCs); (iv) Employees' Pension Scheme (EPS), 1995 implemented through EPFO; (v) Aatmanirbhar Bharat Rojgar Yojana (ABRY) to incentivize employers for creation of new employment and restoration of loss of employment during Covid-19 pandemic; (vi) Rehabilitation of Bonded Labourers for identification and rehabilitation of bonded labourers; and (vii) health services through Employees State Insurance Corporation.

The details of expenditure under major welfare schemes and number of beneficiaries, including the State of Maharashtra and UT of Dadra and Nagar Haveli are Annexed.

As on 31.03.2024, total beneficiaries are 60.49 Lakh, out of which 9.79 Lakh and 52,911 beneficiaries are in Maharashtra and Dadra and Nagar Haveli, respectively.

- 5. **Rehabilitation of Bonded Labour**: The scheme is demand driven in nature where funds are provided to the State / UT Governments on receipt of proposals from them. However, no proposal of financial assistance has been received from Government of Maharashtra and UT Administration of Dadra and Nagar Haveli during last five years and the current year.
- 6. Employee's State Insurance Corporation (ESIC): Under the ESIC scheme, in the State of Maharashtra, there are 15 hospitals (03 ESIC and 12 ESIS) and 108 dispensaries. There are 48,70,460 insured persons in the State of Maharashtra. The Insured Persons (IPs) of Dadra and Nagar Haveli are included with the number of IPs of the Regional Office Ahmedabad. Total Insured Persons attached with Regional Office Ahmedabad, Gujarat including those from Dadra & Nagar Haveli as on 31.03.2024 are 8,78,670.
