- (a) the progress made under PM Gati Shakti National Master Plan since its inception;
- (b) the total amount of funds released under the said plan, Year-wise;
- (c) the details of major projects identified by various Departments/Ministries under the said scheme along with the number and estimated cost thereof;
- (d) whether any new Ministries in addition to the initial 21 have been included in such plan and if so, the details thereof;
- (e) the details of locations under Tirunelveli district included under the said plan;
- (f) the details of the projects launched in Uttarakhand under the said plan and the funds allocated therein; and
- (g) the details of steps being taken for continuous planning and coordinated execution of infrastructure projects in a timely manner?

(a) to (g): A Statement is laid on the Table of the House.

### STATEMENT REFERRED TO IN REPLY TO PARTS (a) to (g) OF LOK SABHA STARRED QUESTION NO. 432 FOR ANSWER ON 01<sup>ST</sup> APRIL 2025.

(a): PM GatiShakti National Master Plan (PMGS NMP) was launched on 13th October 2021. Since its launch, substantial progress has been made, including development of the geospatial platform, integration of multiple data layers, creation of planning tools for infrastructure development (including economic and social infrastructure), and capacity building for officials. An Institutional mechanism of Network Planning Group(NPG) has been set up, under which infrastructure projects (with estimated cost of more than ₹ 500 Crore) are evaluated for integrated planning, multimodality, inter-modality, synchronization of efforts, comprehensive development in and around the project location, and data-driven decision making.

As on date, 36 States/UTs and 44 Central Ministries including 8 Infrastructure, 16 Social, 15 Economic and 5 other Ministries, have been onboarded on PMGS NMP. The 1652 data layers, including 934 layers from 36 States/UTs and 718 layers from 44 Central Ministries, have been integrated on the PMGS NMP. Year wise progress made under PMGS is given in **Annexure-A.** 

(b): Ministry of Finance, Department of Expenditure through Part-II (for PMGS related expenditure) of the "Scheme for Special Assistance to States for Capital Investment for 2022-23" made a provision of ₹ 5000 crores for disbursement among the States for infrastructure development in the form of 50 years interest-free loan.

Details of projects of the States, approved under the Part-II of the "Scheme for Special Assistance to the States for Capital Investment" and funds allocated are given at **Annexure-B.** 

(c): In 89 Network Planning Group (NPG) meetings held under PMGS, 260 infrastructure projects, having estimated cost of ₹ 12.45 lakh Crore, of different Central Ministries have been evaluated to assess the integrated planning approach, ensuring first and last-mile connectivity and comprehensive areabased socio-economic development. The Ministry/Department wise details of these projects is given below:

- (d): As on date, 44 Central Ministries including 8 Infrastructure, 16 Social, 15 Economic and 5 other Ministries have been onboarded on PMGS NMP. The details are given in **Annexure-C.**
- (e): Out of the 260 projects evaluated by Network Planning Group under the PMGS, as given in part (c) above, 07 projects fall under the State of Tamil Nadu. The details are given in **Annexure-D.**
- (f): Out of the 260 major projects planned and evaluated by Network Planning Group under the PMGS, as given in part (c) above, 03 projects fall under the State of Uttarakhand. Details given in **Annexure-E**.
- (g): An institutional mechanism of the Network Planning Group (NPG) and a dedicated GIS-based portal (PMGS NMP) have been setup for integrated planning of infrastructure projects. The NMP portal enables holistic planning and data-driven decision-making by central Ministries and States/UTs. Network Planning Group (NPG) mechanism has been institutionalized under which NPG meetings are held regularly, bringing together stakeholders from all Infrastructure Ministries along with representatives from Ministry of Environment, Forest & Climate Change (MoEFCC), Ministry of Defence (MoD), NITI Aayog and States/UTs. The NPG evaluate projects on the basis of PMGS principles such as integrated planning, multi-modality, inter-modality, whole of Government Approach, and last-mile connectivity.
