- (a) whetherlabourers under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) have been declining in the State of Kerala;
- (b) if so, the details thereof, district-wise;
- (c) the total number of beneficiaries of Kerala under MGNREGS during the last five years, district-wise;
- (d) whether there is a demand from the dairy sector to include labourers engaged under the cattle fodder production as well as the related dairy sector to be included under MGNREGS; and
- (e) if so, the details thereof?

(a)& (b): Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) is a demand driven wage employment Scheme which provides for the enhancement of livelihood security of the households in rural areas of the country by providing at least one hundred days of guaranteed wage employment in every financial year to every household whose adult members volunteer to do unskilled manual work. It is a fall back option which provide livelihood security to the rural households, when no better employment opportunity is available. Details of yearwise registered workers in Kerala under Mahatma Gandhi NREGS during the last three financial years and the current financial year 2024-25 (as on 26.03.2025) is given below:

- (c): District-wise number of workers who availed employment in Kerala under Mahatma Gandhi NREGS during the last five financial years from 2019-20 to 2023-24 are given at Annexure-II.
- (d)& (e): As per Section 29 of the Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA), Central Government may add new works to the permissible list of works under Schedule 1 of the Act. The revision of permissible works is a regular exercise under the Scheme. As and when any request for inclusion of any work in the list of permissible activities under

Mahatma Gandhi NREGS are received from State Government or need for the same is felt by the Central Government, the matter is examined on merit and a decision is taken.

Under the Scheme, several activities related to the dairy sector, including the creation of infrastructure for livestock promotion, such as poultry shelters, goat shelters, piggery shelters, cattle shelters, and fodder troughs for cattle are already covered. Additionally, the development of silvipasture grasslands for fodder on individual and community lands is an allowable activity under Mahatma Gandhi NREGS. These provisions facilitate the construction of assets that support livestock rearing and fodder production, thereby benefiting the dairy sector.

Here, it is mentioned that as per para 4(3) of Schedule-I of Mahatma Gandhi National Rural Employment Guarantee Act, "works which are non-tangible, not measurable, repetitive in nature such as, removing grass, pebbles, agricultural operations, shall not be taken up under the scheme".
