Will the Minister of FINANCE

be pleased to state:

- (a) the details and the total number of green projects financed with the proceeds of sovereign green bonds, classified year and State-wise especially from Andhra Pradesh;
- (b) the details regarding the physical and financial progress of such green projects, year and State-wise especially from Andhra Pradesh;
- (c) whether the Government has conducted any audit of the green projects financed through sovereign green bonds; and
- (d) if so, the details thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PANKAJ CHAUDHARY)

- (a) & (b) The details are provided in the Annexure.
- (c) & (d) The audit of projects financed through Sovereign Green Bonds (SGrB) is conducted by the Comptroller and Auditor General of India (CAG) as part of its regular auditing process. As per information provided by CAG, no audit has been conducted for these projects as of now.

The details and the total number of green projects financed with the proceeds of SGrBs, as well as the physical and financial progress of such projects (year-wise and state-wise, including Andhra Pradesh), are provided below.

A. Project Sector: Sustainable Management of Living Natural Resources and Land use

National Mission for a Green India (Implementing Ministry: Ministry of Environment, Forests and Climate Change)

National Mission for a Green India (GIM) is one of the eight Missions outlined under the National Action Plan on Climate Change. It aims at protecting, restoring, and enhancing India's forest cover and responding to Climate Change by undertaking plantation activities in the forest and non-forest areas in the selected landscapes. GIM activities were started in the FY 2015-16. So far, a sum of ₹962.87 crores has been released to seventeen States and one union territory including Andhra Pradesh for creation of plantation/eco-restoration activities over an area of 155130 ha.

Green India Mission is included under Sovereign green Bond for funding since FY 2022-23. A sum of ₹350.67 crore has been released to the States for taking up the GIM (afforestation) activities in the selected landscapes. The State wise funds released and creation of plantation/eco-restoration work done since FY 2022-23 to till date is detailed as below:

D. Renewable Energy Projects (Implementing Agencies: Ministry of New and Renewable Energy)

a. PM KUSUM:

PM KUSUM scheme is flagship program of MNRE. The main objectives of the scheme include dedieselization of the farm sector, providing water and energy security to farmers, increasing the income of farmers, and curbing environmental pollution. The Scheme has three components targeted to achieve solar power capacity addition of 34.8 GW by 31.3.2026 with total central financial support of Rs. 34,422 Cr. The grants from FY 2022-23 to FY 2024-25 were provided from Sovereign Green Bonds

The funds are disbursed to central agency, i.e. IREDA, for onward disbursal to private developers and not to States.

c. Grid connected Solar Power

Two schemes have been funded under the Grid connected solar power projects- CPSU Scheme Phase II and Rooftop Solar Program. The total allocation of SGrBs towards these schemes is Rs. 1256 crores, Rs. 4000 crores and Rs. 2007 crores in the year 2022-23, 2023-24 and 2024-25 respectively. However, the Ministry has spent over and above these allocations from the general revenue of the Government.

i. CPSU Scheme Phase II

The Ministry of New and Renewable Energy (MNRE), Government of India, is implementing CPSU Scheme Phase-II (Government Producer scheme) for setting up Grid Connected Solar Photovoltaic (PV) Power Projects by Central Public Sector Undertakings (CPSUs) with Viability Gap Funding (VGF) support. The total funds released from SGrBs under this scheme is Rs. 1.77 crores, Rs. 1099 crores and Rs. 562 crores in the year 2022-23, 2023-24 and 2024-25 (till 31.12.2024) respectively. The funds are disbursed to central nodal agency, i.e. SECI & IREDA, for onward disbursal to central PSUs and not to states. Under this scheme, as on 31.12.2024, around 1.8 GW of solar power projects have been commissioned.
