Will the Minister of EDUCATION be pleased to state:

- (a) the details of amount sanctioned, allocated and utilised under Samagra Shiksha Abhiyan (SSA) in Rajasthan during the last five financial years, year-wise;
- (b) the number of schools which received grants under SSA in Rajasthan, district-wise;
- (c) whether the Government proposes other schemes for all round development of children and if so, the details thereof;
- (d) whether the Government proposes to open new Navodaya Vidyalaya in Barmer district of Barmer Parliamentary Constituency;
- (e) if so, the time by which it is likely to be opened; and
- (f) if not, the reasons therefor?

(a): The details of amount sanctioned, allocated and utilized under Samagra Shiksha Scheme in Rajasthan during the last five financial years is given below:

- (b): The district-wise number of schools receiving grants under Samagra Shiksha Scheme in Rajasthan in the year 2024-25 is at Annexure.
- (c): Following Centrally Sponsored education schemes/programmes are being implemented by the Government in the State of Rajasthan:
  - (i) The Department of School Education and Literacy is implementing an Integrated Centrally Sponsored Scheme for School Education Samagra Shiksha w.e.f. 2018-19. The scheme aims to ensure that all children, from pre-school to class 12, have access to quality education with an equitable and inclusive classroom environment which should take care of their diverse background, multilingual needs, different academic abilities and make them active participants in the learning process. The scheme aligns with the National Education Policy 2020 and Sustainable Development Goal (SDG-4) which focuses on quality education. The scheme also targets foundational literacy and numeracy, holistic and integrated curriculum and innovative pedagogical methods, aiming to bridge social and gender gaps in education.
  - (ii) Strengthening Teaching-Learning and Results for States (STARS) Project, supported by the World Bank, is being implemented as a Centrally Sponsored Scheme (CSS) in the state over a period of 5 years, i.e., from F.Y. 2020-21 to F.Y. 2024-25 and aims at improving the assessment system in schools and ensuring equal education for all. STARS Project supplements the efforts of Samagra Shiksha scheme for the school education sector. It encompasses teachers and students from pre-primary to 12th standard as beneficiaries.
  - (iii) The Pradhan Mantri Schools for Rising India (PM-SHRI), a Centrally Sponsored Scheme is being implemented in the State. This scheme has been approved for a period of 5 years w.e.f. 2022-23 to 2026-27. Under this scheme, 734 schools have been selected in Rajasthan for development as exemplar schools to showcase various components of NEP 2020.
  - (iv) **Pradhan Mantri Poshan Shakti Nirman (PM POSHAN)** is one of the foremost rights based Centrally Sponsored Scheme implemented in partnership with the States and UTs for providing one hot cooked meal to children studying in Balvatika (preprimary classes) and classes I to VIII of Government and Government-aided schools on all school days.
- (d) to (f): The Navodaya Vidyalaya Scheme envisages for opening of one NV in each district of the country.

With sanctioning of 62 new NVs in November 2016, all 638 districts (as on 31st May, 2014) of the States/UTs which have accepted the scheme, other than 6 districts with 100% urban population, have been covered under this scheme. All the districts of Rajasthan (created up to 31.05.2014) have been covered under Navodaya Vidyalaya Scheme. Further, Government of India has recently sanctioned new NVs in 28 newly created/ carved out districts.

Opening of new NVs is a continuous process which depends on the willingness of the concerned State Government/UT administration to make available requisite suitable land, free of cost, for construction of the permanent building and making available required temporary building, free of rent, to run the Vidyalaya till the permanent building is constructed. Sanction and opening of new NVs depends on approval by the competent authority as per extant procedures
