TRAINING UNDER DTNBWED SCHEME

109. SHRI KESINENI SIVANATH:

Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a)whether the Government has any data regarding the total number of persons trained under the Sponsored Short Term Training Programme [SSTTP] of Dattopant Thengadi National Board for Workers Education and Development (DTNBWED) scheme, if so, the details of the last five years, State-wise;
- (b)the details regarding the breakup of the total budget allocated to the different components of the DTNBWED scheme, the details of the last five years;
- (c)whether the Government is tracking the total number of people secured jobs after the training process, if so, the details thereof especially in the state of Andhra Pradesh; and
- (d)whether the Government has any proposals for expanding the number of programmes conducted in the organized and unorganized sector, if so, the details thereof?

ANSWER

MINISTER OF STATE FOR LABOUR AND EMPLOYMENT (SUSHRI SHOBHA KARANDLAJE)

(a): The Sponsored Short Term Training Programme (SSTTP) is a demand-based programme for Trade Union/NGOs/Industries Association/Chamber of Commerce/Contractor/Mining Bodies etc. and it started in the Financial Year 2022-23.

A total of 1675199 workers have been trained during the last 03 years (FY-2022 to FY-2025) across the country by the Board, out of which 57151 workers have been covered under SSTTP Programmes. The year wise and state-wise details are enclosed at Annexure.

(b): The total budget allocated to the different components of the DTNBWED scheme for the last five years is as under:

(c): No, there is no such mechanism for tracking people after the training process.

(d): To amplify the reach of the training programme, DTNBWED has developed a synergized working platform wherein various working groups in the field of workers welfare collaborate to work together. As a pilot project, such joint effort-based workers' programmes have been conducted at Delhi, Bangalore and Mumbai, resulting in an expanded outreach. Encouraged by these results, the Board is chalking out a plan to carry out similar joint efforts in other States/UTs as well.
