Teacher Training Programmes under Samagra Shiksha Abhiyan

10. Shri Mani A:

Will the Minister of EDUCATION be pleased to state:

- (a) the details of the types of training programmes available for teachers under the Samagra Shiksha Abhiyan and the measures followed by the Government to ensure that teachers are equipped with modern teaching methodologies;
- (b) the details of the number of teachers trained in the various programmes and its impact on teaching quality;
- (c) the content and methodologies used in the teacher training programmes under the Abhiyan;
- (d) the measures being taken by the Government to ensure that teachers in rural and remote areas have access to quality training programmes under the Abhiyan;
- (e) the budget allocated for teacher training programmes under the Abhiyan and the increase in funding for these programmes over the years; and
- (f) whether the Government has conducted any assessments on the impact of these training programmes on teaching quality and student learning outcomes?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SHRI JAYANT CHAUDARY)

(a)to (e): Strengthening of teacher training/education programmes is supported under the centrally sponsored scheme of Samagra Shiksha in alignment with the recommendations of the National Education Policy (NEP), 2020. The interventions under Samagra Shiksha are aimed at strengthening of physical infrastructure in Teacher Education Institutions (TEIs); support to State Councils of Educational Research and Trainings (SCERTs) so that they can effectively and efficiently carry out quality teacher education, research and develop state-specific curriculum framework, as a follow up to the National Curriculum Framework for School Education (NCF SE); capacity building of District Institute of Education and Training (DIET) functionaries; continuous academic support to schools through BRC/CRC etc.

Financial provision is provided under this scheme as per state specific proposals for in-service training of teachers, school Heads, subject teachers, resource persons, master trainers, Education Administrators, Teachers Educators, key resource persons, induction training of newly recruited teachers including those in rural and remote areas at elementary and secondary levels through SCERTs and DIETs, as the nodal agencies.

The details of teacher training allocated under Samagra Shiksha in the last three years are available in Annexure at https://www.education.gov.in/parl ques.

The Department of School Education and Literacy has also launched a National Mission to improve learning outcomes at the elementary level through an Integrated Teacher Training Programme called NISHTHA – National Initiative for School Heads' and Teachers' Holistic Advancement under the Centrally Sponsored Scheme of Samagra Shiksha. NISHTHA is a capacity building programme for "Improving Quality of School Education through Integrated Teacher Training". NISHTHA online was launched using DIKSHA platform in October, 2020. NISHTHA training has been extended to secondary stage teachers in 2021-22. Subsequently, NISHTHA also extended to Foundational Literacy and Numeracy and Early Childhood Care and Education (ECCE) for training of master trainers.

The Government has decided to develop all functional 613 District Institutes of Education and Training (DIETs) into Centers of Excellence under the centrally sponsored scheme of Samagra Shiksha in a phased manner starting from FY 2023-24. Based on proposals submitted by States/UTs for the FY 2023-24, the Government has sanctioned a financial assistance of Rs. 92,320.18 Lakhs for upgradation of 125 DIETs of 33 States/UTs out of which a total of Rs. 30,559.13 Lakhs have been released to 29 States/UTs as central share.

Further, in terms of NEP, 2020, the Government has released a Guiding Document on the National Professional Standards for Teachers (NPST) and Bluebook on the National Mission for Mentoring (NMM). NPST defines competencies of teachers at different stages/levels. The Bluebook on NMM contains the various modalities for mentoring of schoolteachers for enhancing their capacity building.

(f): In order to diagnose learning gaps and determine interventions necessary in policies, teaching practices and learning, the Government conducts National Achievement Survey (NAS) in a cycle of three (03) years. NAS (now referred to as PARAKH Rashtriya Sarvekshan) is a national level assessment about learning achievements in schools and was recently conducted on 03rd December, 2024.
