- (a) the details of technical textile parks set up in the country, State and location-wise including Maharashtra and Uttar Pradesh;
- (b) whether the Government proposes to set up MIDC's technical textile park at Kaudgoan in Osmanabad Parliamentary Constituency of Maharashtra and Lalganj Parliamentary Constituency of Uttar Pradesh;
- (c) if so, the details thereof and if not, the reasons therefor;
- (d) whether the Government has received any proposal from the Government of Maharashtra and Uttar Pradesh in this regard;
- (e) if so, the action taken by the Government in this regard;
- (f) whether the Government has given priority to the proposal for generating employment in Osmanabad and Azamgarh in view of being aspirational districts;
- (g) if so, the details thereof; and
- (h) the details of the other schemes being implemented by the Government in Osmanabad Parliamentary Constituency of Maharashtra and Azamgarh Parliamentary Constituency in Uttar Pradesh?

(a) to (h): With a view to develop integrated large scale and modern industrial infrastructure facility for entire value-chain of the textile industry, the Government has approved setting up of 7 (Seven) PM Mega Integrated Textile Region and Apparel (PM MITRA) Parks in Greenfield/Brownfield sites with scheme outlay of Rs. 4,445 crore for the period 2021-22 to 2027-28. It is expected that each PM MITRA Park when completed, would generate 3 lakh (both direct/indirect) jobs.

All States including Maharashtra and Uttar Pradesh were requested to submit proposal(s) for setting up of PM MITRA Park in respective States. In response, 18 proposals from 13 State Governments including two from Maharashtra (Aurangabad and Amrawati) and one from Uttar Pradesh (Lucknow) were received. The Government has finalised 7 sites including one each in Amravati Maharashtra and Lucknow Uttar Pradesh for setting up PM MITRA Parks.

PM MITRA Park will offer the opportunity to create an Integrated Textiles Value Chain right from spinning, weaving, processing, and printing to garment manufacturing, accessories makers at one location reducing logistics & transaction cost. Man-made Fibre (MMF) and Technical Textiles are expected to be an important component of new investments in these parks. No proposal for setting up of Technical Textile Park in Maharashtra and Uttar Pradesh is pending in the Ministry.

The Ministry is also implementing (SAMARTH)- Scheme for Capacity Building in Textile Sector (SCBTS), with the objective to provide demand driven, placement oriented National Skill Qualification Framework (NSQF) compliant skilling programmes to incentivize and supplement the efforts to the industry in creating jobs in the organized textile (excluding spinning & weaving) and related sectors and to provide skilling and skill-upgradation in the traditional sectors. As on 03.02.2025, a total of 3,57,949 beneficiaries have been trained (passed) and 2,86,206 beneficiaries have been placed under “SAMARTH”.

In addition, the Ministry of Textiles is implementing various schemes/initiatives across the country to promote the textiles sector. The major schemes/initiatives include National Technical Textiles Mission (NTTM) which was launched with a view to boost technical textiles sector in the country, ATUFS to incentivize technology upgradation and modernization through capital investment subsidy for eligible investment in benchmarked textile machinery; Silk Samagra-2 for comprehensive development of sericulture value chain ; National Handloom Development Program (NHDP) and National Handicraft Development Program (NHDP) for end to end support for handloom and handicraft sectors etc.

Maharashtra Integrated and Sustainable Textile Policy 2023-28 provides significant incentives for the establishment of Technical Textiles Parks which includes capital subsidy, support for establishment of ETPs, CETPs, ZLDs, and Solar Plants. The policy also encourages setting up of common facility centers and promotion of R&D activities.

As per this policy, Government of Maharashtra has introduced a range of incentives for the establishment of six technical textiles parks across Maharashtra, with equal subsidy support across all zones.

As per Uttar Pradesh Textile and Garmenting Policy 2017 & 2022, State Government is providing additional incentives to the units located in Poorvanchal region of the State.
