- (a) The total number of proposals received under the Animal Husbandry Infrastructure Development Fund (AHIDF) in Andhra Pradesh, categorized by infrastructure type and applicant type since the scheme's inception, district and year-wise;
- (b) The number of individual entrepreneurs, MSMEs, FPOs and private companies that have availed the scheme, along with the financial support received by each category;
- (c) The details of proposals rejected, along with the reasons for their rejection, district-wise;
- (d) The average time taken to approve proposals under AHIDF in Andhra Pradesh and the measures taken to expedite the approval process; and
- (e) The specific challenges faced by applicants in Andhra Pradesh and what steps are being taken to address them?

**ANSWER**

- a) The details of total number of proposals received under the Animal Husbandry Infrastructure Development Fund (AHIDF) in Andhra Pradesh, Categorized by infrastructure type, since the scheme inception, District and year wise are enclosed at **Annexure I** and **Annexure II**
- b) The details of individual entrepreneurs, MSMEs, FPOs, and Private Companies that have availed of the scheme, along with the financial support received by each category is enclosed at Annexure III.
- c) The details of the 150 proposals rejected/ineligible projects as per the portal of AHIDF for the state of Andhra Pradesh, along with the major reasons for their rejection, district wise is enclosed at Annexure -IV.
- d) The average time taken for approval of applications received on the AHIDF portal is approximately three months, depending on the nature of the projects and compliance requirements. To streamline and expedite the approval process, the Department of Animal Husbandry and Dairying, Government of India has undertaken the following measures:
  - i. Conducting rigorous follow-ups with lending institutions and promoters to ensure timely sanctions and compliance.

- ii. Organizing periodic meetings with bankers and hosting regional webinars.
  - iii. Facilitating promoters at various stages to ensure smooth project implementation.
  - iv. Updating the online portal with essential documents and Standard Operating Procedures (SOPs).
  - v. Linking the AHIDF portal to Common Service Centers (CSCs) to simplify the application process at the village level.
  - vi. Central Level Bankers Coordination Committee (CLBCC) has been constituted to take joint reviews with banks to expedite early disposal of cases.
- e) No specific challenges have been reported by beneficiaries from Andhra Pradesh to the Department of Animal Husbandry and Dairying. To assist applicants during the pre-application and application stages, dedicated telephone lines and email support are available on the online portal ([ahidf.udyamimitra.in](http://ahidf.udyamimitra.in)). Additionally, State Animal Husbandry Departments have designated nodal officers to ensure the smooth implementation of projects. A mechanism for rigorous follow-ups with lending institutions and promoters has also been established to address challenges and expedite projects under the scheme.

To enhance outreach and address challenges faced by potential beneficiaries and entrepreneurs, the department of Animal Husbandry and Dairying, Government of India regularly conducts conclaves, webinars, and promotional events.
