# GOVERNMENT OF INDIA MINISTRY OF PANCHAYATI RAJ LOK SABHA UNSTARRED QUESTION NO. 1374 ANSWER DATE 11.02.2025

#### SVAMITVA PROGRAMME

Will the Minister of PANCHAYATI RAJ be pleased to State:

(a) whether any measures have been implemented to enable property owners in rural areas to easily access loans based on their property cards, if so, the details thereof;

(b) the steps taken by the Government to finalize the survey after completion of 92 percent of drone mapping and the plan of the government to ensure achieving the target of covering 3.44 lakh villages by 2026;

(c) whether it is a fact that 31 States and UTs have joined the Survey of Villages and Mapping with Improvised Technology in Village Areas (SVAMITVA) programme and the reason due to which States like Telangana, Tamil Nadu, Sikkim and Maharashtra only participate in the pilot phase alongwith the details of the reasons they have not yet fully adopted the scheme;

(d) the details of major targets and time-line fixed for providing full coverage to 3.44 lakh villages under the SVAMITVA scheme as the said programme has to be completed by 2026, State and district-wise including Maharashtra;

(e) the details of the drone mapping completed, property card issued and the survey done in the Palghar district in Maharashtra; and

(f) the details of reasons behind no fully adopting the SVAMITVA scheme so far by some States like Telangana, Tamil Nadu, Sikkim and Maharashtra which have participated only in the pilot phase while the remaining thirty one States and Union Territories have joined the said scheme?

### ANSWER

### MINISTER OF STATE FOR PANCHAYATI RAJ

#### (PROF. S. P. SINGH BAGHEL)

(a): One of the primary objectives of the SVAMITVA scheme is to facilitate access to institutional credit/bank loans for the residential property owners in the rural areas by providing property cards, which are legally recognized under the relevant Laws/Rules, and

accepted by Banks / Financial Institutions for mortgaging of property for loans. To promote this, States/UTs are actively engaging with State-Level Bankers' Committees (SLBCs) through inclusionof SVAMITVA Scheme in SLBC quarterly meeting agendas to sensitize banks about recognizing and providing loans against these property cards. Positive outcomes have been reported in various States including Madhya Pradesh, Maharashtra, and Rajasthan, where beneficiaries have successfully secured bank loans using their property cards.

(b): The Ministry of Panchayati Raj has established clear targets for SVAMITVA implementation. States and UTs are expected to complete drone surveys by March 2025 and property card preparation for rural Abadi areas in all the States/UTs by March 2026. To achieve this, milestone-based targets are set for States/UTs and the Survey of India, providing a roadmap for progress. Regular review meetings with stakeholders are held to ensure prompt identification of issues and their resolution. A four-tiered monitoring system (National to Panchayat level) ensures comprehensive oversight, complemented by an online dashboard (<a href="http://www.svamitva.nic.in">www.svamitva.nic.in</a>) providing village-level progress updates. The Ministry also provides dedicated "handholding" support to States/UTs.

(c & f): Till date, 31 States/UTs have onboarded the SVAMITVA scheme. In Maharashtra, all revenue villages with Gaothan (Abadi area) have been covered. Tamil Nadu has reported preexisting Natham area records which legal validity for availing bank loans and did not extend the SVAMITVA scheme beyond the villages covered in the pilot phase. Telangana opted not to extend the scheme beyond the pilot phase. Sikkim has participated in the pilot phase but ;aterconfined the scheme to the CORS network only,citing the absence of distinct "Abadi" area in the villages.

(d): The SVAMITVA scheme targets 3.46 lakh inhabited rural villages (as notified by States/UTs). Currently, drone flying has been completed in 3.18 lakh villages (92% of the target) and 2.38 crore property cards prepared for over 1.59 lakh villages. State-wise details of targeted villages and progress are in Annexure. Drone surveys have been completed in Andhra Pradesh, Madhya Pradesh, Uttar Pradesh, Chhattisgarh, Delhi, Ladakh, Dadra & Nagar Haveli and Daman & Diu, and Lakshadweep. The scheme has achieved saturation in Haryana, Uttarakhand, Puducherry, Goa, Tripura, and Andaman & Nicobar Islands. Drone surveys are targeted for completion in the targeted Districts/Villages in various States/UTs, including Maharashtra, by March 2025, with targeted saturation of the Scheme by March 2026.

(e): In Palghar district, Maharashtra, drone surveys are complete in 759 villages, and 49,028 property cards have been issued in 431 villages.
