#### 1389. SHRI BRIJENDRA SINGH OLA:

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) whether any study has been conducted by the Government on the possibilities of increasing farmers income and employment from food processing sector in the country;
- **(b)** if so, the details thereof;
- (c) the details of the number of food parks in the country;
- (d) the details of the number of food parks approved/ started by the Government during the last five years and the current year, State-wise
- (e) the total number of people employed in the food processing sector in registered and unregistered units; and
- (f) the number of people likely to get employment from new food parks

#### **ANSWER**

# THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

- (a): The Ministry of Food Processing Industries (MoFPI) has not conducted any study on the possibilities of increasing farmers' income and employment from food processing sector in the country.
- **(b):** In view of (a) above, the question does not arise.
- (c): Under the Scheme for Mega Food Parks, 41 projects have been approved across the country. The Scheme for Mega Food Parks has been discontinued w.e.f. 01.04.2021 with provision for committed liability during 15th Finance Commission cycle.
- (d): The list of the number of mega food parks approved/ started by MoFPI during the last five years and the current year, State-wise is provided at **Annexure**.
- (e): As per the latest Annual Survey of Industries 2022-23, 22.96 lakh persons are employed in registered food processing units and as per the Annual Survey of Unincorporated Sector Enterprises 2022-23, 46.57 lakh persons are employed in unregistered food processing units in the country.
- **(f):** The Scheme for Mega Food Parks has been discontinued w.e.f. 01.04.2021 with provision for committed liability during 15<sup>th</sup> Finance Commission cycle.
