1400. SHRI V K SREEKANDAN: ADV DEAN KURIAKOSE:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

(a) the number of people included in Particularly Vulnerable Tribal Groups (PVTGs) under the Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM-JANMAN) scheme in Kerala, including Attapadi in Palakkad district;

(b) the amount of funds sanctioned under the PM-JANMAN scheme to Kerala during the last two years;

(c) the major projects initiated and the infrastructures created under the PM-JANMAN scheme in Kerala, including Attapadi where a number of tribal hamlets exist; and

(d) whether the Government has fixed any time-frame to achieve the objectives of the said scheme in tribal areas, including the said district and if so, the details thereof?

ANSWER

MINISTER OF STATE FOR TRIBAL AFFAIRS (SHRI DURGADAS UIKEY)

(a) to (d): Ministry of Tribal Affairs through the State Governments/ UT Administration/departments has undertaken habitation level data collection exercise through PM Gati Shakti mobile application to estimate PVTG population figures and infrastructure gaps in order to cover PVTG population residing in villages & habitations covered under PM JANMAN. Based on the data captured (as on 31.01.2025), PVTG population, District-wise, in the State of Kerala is tabulated at **Annexure-I**. However, the actual number beneficiaries to be covered under Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM JANMAN) is subject to eligibility criteria of specific guidelines of concerned interventions as per approved norms. The details of funds sanctioned and progress under PM JANMAN to the State of Kerala including Attapadi block (as on 14.01.2025) is at **Annexure-II**. The mission is approved for the period 2023-24 to 2025-26.
