- a) the details of financial assistance provided by the Government to the State Government of Bihar during the last five years including the current year, scheme-wise and year-wise;
- b) the details of funds released to the Government of Bihar during the last five years as per Finance Commission Recommendations and under the Heads of Grant-in-Aid and Special Assistance; and
- c) the progress made in each scheme in Bihar during the said period?

(a) to (c): The Union Government provides funds to the State Governments including the state government of Bihar under various heads such as Tax Devolution, Finance Commission Transfers, Grant-in-Aid for Centrally Sponsored Schemes (CSS), Special Assistance (Grant) and Scheme for Special Assistance to States for Capital Expenditure/Investment. In addition, funds are released in various Central Sector Schemes to be utilized in the State of Bihar. Details of funds provided/released to the state government of Bihar under these heads during the last five years and the current year are given in Annexure:
