Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the details regarding the total number of MSME registrations during the last five years in the country especially in Andhra Pradesh, category-wise;
- (b) the details regarding the total contribution to GDP by the MSME sector during the last five years in a category-wise manner in the country especially those registered in Andhra Pradesh;
- (c) whether the Government has undertaken any steps towards the recognition of nano-enterprises in the country during the last five years and if so, the details thereof;
- (d) whether the Government has considered/received any proposal regarding the recognition of nano-enterprises in the MSME categorization matrix;
- (e) if so, the details regarding the same including total registrations so far under nano-enterprises; and
- (f) whether the Government is implementing schemes/taking initiatives to support nano-enterprises across the country especially in Andhra Pradesh, if so, the details thereof and if not, the reasons, therefor?

ANSWER

- (a): Udyam Registration Portal was launched on 01.07.2020. As on 31.01.2025 the total number of MSMEs registered in the country on the Udyam Registration Portal and Udyam Assist Platform is 5,91,55,513. The category-wise details including for Andhra Pradesh given in Annexure.
- (b): As per the latest information received from the Ministry of Statistics & Programme Implementation, the share of MSME Gross Value Added (GVA) in all India GDP from 2018-19 to 2022-23 is given below:
