- (a) The State/UT-wise details of expenditure incurred for development and maintenance of National Highways (NHs), and the length constructed during the last five years are annexed.
- (b) Tolling of NHs is taken up after issue/declaration of Completion Certificate (CC) / Commercial Operation Date (COD) upon completion of the project stretch or after issue/declaration of Provisional Completion Certificate (PCC) / Provisional Commercial Operation Date (PCOD) upon completion of substantial length of the project stretch, whereas length constructed is reported on continuous basis during the construction/improvement phase. Information on project stretches completed (CC/COD) or provisionally completed (PCC/PCOD) during the last five years where tolling has been taken up, and project stretches completed (CC/COD) or provisionally completed (PCC/PCOD) during the last five where tolling has not been taken up, is being collected.
