CSR Funds Generated by Companies in Saharanpur

QUESTION

†1667. Shri Imran Masood:

Will the Minister of CORPORATE AFFAIRS be pleased to state:

- (a) whether section 135(5) of the Companies Act, 2013 provides for preference in spending CSR funds in the local or nearby areas where the company operates;**
- (b) the quantum of CSR funds allocated by companies located in Saharanpur district, Uttar Pradesh during the last five financial years, company-wise;**
- (c) the CSR fund spent by these companies in the local or nearby areas during the abovementioned years, year-wise; and**
- (d) the funds spent on education, health, environment, rural development and vocational skills separately in Saharanpur district and the rest of the country, year-wise and company-wise?**

(a): The first proviso to Section 135 (5) of the Act provides that the company shall give preference to the local area and areas around it where it operates. However, the emphasis on local area is only directory and not mandatory in nature and companies need to balance local area preference with national priorities. Under the Act, CSR is a Board driven process and the Board of the company is empowered to plan, decide, execute and monitor CSR activities based on the recommendation of its CSR Committee.

(b): There is no provision of allocation of CSR funds under CSR legal framework. However, all data related to CSR filed by companies in MCA21 registry is available in public domain and can be accessed at www.csr.gov.in. Moreover, CSR expenditure made by the Companies in Saharanpur District during the last five Financial Years (FYs) i.e. years i.e. 2018-19 to 2022-23 is attached at Annexure-I.

(c): The CSR funds spent by the companies in Saharanpur District of Uttar Pradesh during last five Financial Years (FYs) i.e years i.e. 2018-19 to 2022-23 is attached at Annexure-II.

(d): On the basis of filings made by the companies in the MCA21 registry, the CSR spent on the Development Sector-wise in the district of Saharanpur of Uttar Pradesh and rest of the country for the last five financial years (FYs) i.e. years i.e. 2018-19 to 2022-23 is attached at Annexure-III and Annexure-IV respectively.
