Schemes for Welfare of Farmers by NABARD

- (a) the scheme implemented by National Bank for Agriculture and Rural Development for the welfare of farmers in Bihar;
- (b) the funds dispersed by National Bank for Agriculture and Rural Development in Bihar during the last three years, district-wise;
- (c) whether the Government proposes to implement any other scheme for welfare of farmers; and
- (d) if so, the details thereof?

Answer

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PANKAJ CHAUDHARY)

(a) to (b): NABARD is implementing various schemes for welfare of farmers in Bihar which, inter-alia, include:

i. Setting up of infrastructure such as irrigation projects, rural roads, bridges, godowns, cold storages, etc. through the Rural Infrastructure Development Fund (RIDF)

ii. Grant Support for various schemes for farm sector development through Watershed Development Fund (WDF), Tribal Development Fund (TDF), Farm Sector Promotion Fund (FSPF) etc.

iii. Grant support under Producer Organization Development Fund (PODF) and Central Sector

Scheme – Formation and Promotion of 10,000 Farmer Producers' Organization (CSS-FPO)

iv. Providing loans to Cooperative banks for procurement and marketing of agri-produce

v. Refinance assistance to banks/ financial institutions for provision of agricultural credit at concessional rates of interest

vi. Grant support for organizing Financial Literacy Camps for farmers

The details of funds disbursed by NABARD during the last three years in Bihar are at Annexure I.

(c) to (d): The Government has implemented various other schemes also for welfare of farmers viz. Timely credit through Kisan Credit Card (KCC) scheme, Income support to farmers through PM KISAN, Pradhan Mantri Fasal Bima Yojana (PMFBY), Micro Irrigation Fund for expanding coverage under micro irrigation, Promotion of Farmer Producer Organisations (FPOs), National Beekeeping and Honey Mission (NBHM), Agri Infrastructure Fund (AIF), Namo Drone Didi scheme etc.
