SPECIAL PROGRAMMES FOR THE CONSERVATION AND PROMOTION OF CULTURAL AND HISTORICAL SITES IN PUNJAB

16. SHRI CHARANJIT SINGH CHANNI:

Will the Minister of CULTURE be pleased to state:

- (a) whether the Government has launched special programmes for the conservation and promotion of cultural and historical sites in Punjab, if so, the details thereof;
- (b) whether any specific sites have been selected under these programmes and if so, the budget allocated for their development; and
- (c) whether the development of these sites has benefited the local communities and if so, the details of these benefits?

ANSWER

MINISTER OF CULTURE AND TOURISM (SHRI GAJENDRA SINGH SHEKHAWAT)

(a) Archaeological Survey of India (ASI) takes up conservation and maintenance work of 33 protected monuments/sites including providing amenities in the state of Punjab as per the requirement and availability of resources. ASI conducts various cultural events from time to time specially during the World Heritage Day, World Heritage Week and various other important occasions to promote the cultural and Historical sites.

Development and promotion of tourism destinations and products is primarily undertaken by the concerned State Government /Union Territory Administration. The Ministry of Tourism provides financial assistance to States/ UT Administration under its scheme 'Swadesh Darshan' and 'Pilgrimage Rejuvenation and Spiritual, Heritage Drive (PRASHAD)' Augmentation for tourism infrastructure development and recently sanctioned Scheme for "Special Assistance to States/Union Territories for Capital Investment (SASCI)-Development of Iconic Tourist Centers to Global Scale" for development of cultural and historical sites. The projects under the schemes are sanctioned on receipt of appropriate project proposals. its adherence to the Scheme Guidelines, availability of budget etc.

(b) The details of funds allocated by ASI for conservation and maintenance works for the protected monuments/sites of Punjab State during the last four years are as under:

(c) Undertaking conservation and development works at ASI monuments help to enhance tourists/visitors experience and also create and increase employment opportunities and also strengthen local economy.
