BILATERAL AND MULTILATERAL TRADE

1896. DR. ANGOMCHA BIMOL AKOIJAM:

Will the Minister of **COMMERCE & INDUSTRY** (वाणिज्य एवं उद्योग मंत्री) be pleased to state:

- (a) the details of bilateral and multilateral trade agreements India has with Myanmar and other South-East Asian countries;
- (b) the details of products exported by India to, and imported from, these countries, item and country-wise;
- (c) whether the Government has a trade surplus or deficit with these countries, if so, the details thereof; and
- (d) whether the Government has any plans to expand trade with these countries, if so, and whether such expansion will benefit the people in the bordering States of the North-East; and
- (e) if so, the details thereof?

- (a) India has Trade Agreements on Goods, Services and Investment with Association of South-East Asian Nations (ASEAN) of which, Myanmar is also a member country. India has bilateral trade agreements with some of the ASEAN member countries namely Singapore (India-Singapore CECA), Malaysia (India-Malaysia CECA) and Thailand (Early Harvest Scheme (EHS)).
- (b) The requisite details are available on the website of Department of Commerce at <http://commerce.gov.in> under the link 'Trade statistics' and then 'Export Import Data Bank'.
- (c) A statement showing trade surplus/deficit with ASEAN countries during 2023-2024 is attached as Annexure.
- (d) & (e) Expanding the trade with different countries is a continuous and ongoing process. Accordingly, regular reviews of trade agreements are done to expand trade with ASEAN countries for the benefit of citizen of India including those in the bordering states of the North-East.
